URBANA CITY COUNCIL MEETING
November 15, 1993

The City Council of the City of Urbana, Illinois met in regular session at 7:30 p.m., Monday, November 15, 1993 in the Council Chambers of the Urbana City Building.

Present at the meeting were Members of the Council: Hayes, Pollock, Ryan, Singer (arrived at 7:45 p.m.), Taylor and Whelan - 6.

There being a quorum, the meeting was called to order at 7:32 p.m. by Mayor Tod Satterthwaite.

The Pledge of Allegiance was recited in honor of Veteran's Day.

MINUTES OF PREVIOUS MEETING

Alderman Hayes moved to approve the minutes of the November 1, 1993 regular meeting.

The motion was seconded by Alderwoman Ryan and carried by a voice vote.

ADDITIONS TO THE AGENDA

There were none.

PETITIONS AND COMMUNICATIONS

Mayor Satterthwaite welcomed Cub Scout Pack 124 from Prairie School.

Earl O'Shea, 606A South Glover Street, addressed the Council regarding better government.

Jim Strehlow, 907 South Anderson Street, addressed the Council regarding an Ordinance Annexing Certain Territory To the City Of Urbana (Village Community Development).

Clifford Singer, 412 West Iowa Street, addressed the Council suggesting that An Amendment To A Part Of The Zoning Ordinance Of The City Of Urbana, Illinois And The Zoning Map Of Urbana, Illinois (Abandoned Railroad Right-Of-Way Between McCullough and Orchard Streets) and An Ordinance Granting A Special Use Permit (To Allow Lester Johnson to Locate A Parking Lot On Abandoned Railroad Right-of-Way Between McCullough and Orchard Streets) be sent to Committee for

further discussion.

Alderman Singer took his seat.

Committee on Administration and Finance

Alderman Pollock moved to adopt an Ordinance Revising The Annual Budget Ordinance (S.B.A. Tree Grant - \$29,120). The motion was seconded by Alderman Whelan and carried 7-0 by roll call vote. Voting aye were Members of the Council: Hayes, Pollock, Ryan, Singer, Taylor, Whelan and Mayor Satterthwaite - 7; voting nay: none.

Alderman Pollock moved to adopt An Ordinance Authorizing The Mayor To Execute An Agreement Establishing The "Art In The Park" Fund. The motion was seconded by Alderman Whelan and carried 6-0 by roll call vote. Voting aye were Members of the Council: Hayes, Pollock, Ryan, Singer, Taylor and Whelan - 6; voting nay: none.

Alderman Pollock reported that the next regular meeting of the Committee on Administration and Finance will be December 13, 1993 at 7:30 p.m.

Committee on Environment and Public Safety

Alderman Singer reported that the next regular meeting of the Committee on Environment and Public Safety will be November 22, 1993 at 7:30 p.m.

REPORTS OF OFFICERS

Chief Administrative Officer Bruce Walden reported that an Acting Human Resources Officer has been hired.

NEW BUSINESS

Alderman Taylor moved to adopt an Ordinance Annexing Certain Territory To The City Of Urbana (Village Community Development). The motion was seconded by Alderman Whelan.

Following debate, the motion carried 6-0 by roll call vote. Voting aye were Members of the Council: Hayes, Pollock, Ryan, Singer, Taylor and Whelan - 6; voting nay: none.

Ray Kimpel, Attorney, representing Lester Johnson, addressed the Council in support of An Amendment To A Part Of The Zoning Ordinance Of The City Of Urbana, Illinois And The Zoning Map Of Urbana, Illinois (Abandoned Railroad Right-Of-Way Between McCullough and Orchard Streets) and An Ordinance Granting A Special Use Permit (To Allow Lester Johnson to Locate A Parking Lot On Abandoned Railroad Right-of-Way Between McCullough and Orchard Streets)

Stephen A. Kurth, Altec Engineer, addressed the Council in support of An Amendment To A Part Of The Zoning Ordinance Of The City Of Urbana, Illinois And The Zoning Map Of Urbana, Illinois (Abandoned Railroad Right-Of-Way Between McCullough and Orchard Streets) and An Ordinance Granting A Special Use Permit (To Allow the Lester Johnson to Locate A Parking Lot On Abandoned Railroad Right-of-Way Between McCullough and Orchard Streets)

Following debate, Alderwoman Ryan moved to send An Amendment To A Part Of The Zoning Ordinance Of The City Of Urbana, Illinois And The Zoning Map Of Urbana, Illinois (Abandoned Railroad Right-Of-Way Between McCullough and Orchard Streets) and An Ordinance Granting A Special Use Permit (To Allow the Lester Johnson to Locate A Parking Lot On Abandoned Railroad Right-of-Way Between McCullough and Orchard Streets) to the November 22, 1993 Committee on Environment and Public Safety meeting. The motion was seconded by Mr. Pollock.

Lester Johnson, 1706 West Springfield Avenue, Champaign, spoke in support of An Amendment To A Part Of The Zoning Ordinance Of The City Of Urbana, Illinois And The Zoning Map Of Urbana, Illinois (Abandoned Railroad Right-Of-Way Between McCullough and Orchard Streets) and An

Ordinance Granting A Special Use Permit (To Allow Lester Johnson to Locate A Parking Lot On Abandoned Railroad Right-of-Way Between McCullough and Orchard Streets)

Following further debate, the motion to send to Committee carried by a voice vote.

Alderman Singer moved to adopt An Ordinance Amending The Urbana Local Traffic Ordinance, As Amended (Stop Signs at Goodwin Avenue and Oregon Street). The motion was seconded by Alderman Hayes and carried 5-1 by roll call vote. Voting aye were Members of the Council: Hayes, Ryan, Singer, Taylor and Whelan - 5; voting nay: Pollock - 1.

ADJOURNMENT

There being no further business to come before the Council, Mayor Satterthwaite declared the meeting adjourned at 8:28 p.m.
