

URBANA CITY COUNCIL MEETING
MONDAY, JULY 5, 1994

The City Council of the City of Urbana, Illinois met in regular session at 7:30 p.m., Monday, July 5, 1994 in the Council Chambers of the Urbana City Building.

Present at the meeting were Members of the Council:
Hayes, Patt, Pollock, Ryan, Singer, Taylor and Whelan - 7.

There being a quorum, the meeting was called to order at 7:30 p.m. by Mayor Satterthwaite.

The Pledge of Allegiance was recited in honor of Independence Day.

MINUTES OF PREVIOUS MEETING

Alderman Whelan moved to approve the minutes of the June 20, 1994 regular meeting and June 27, 1994 Special Council Meeting. The motion was seconded by Alderman Hayes and carried by a voice vote.

ADDITIONS TO THE AGENDA

Alderman Singer moved to add the setting of public hearing dates for the Flessner and Mathews Annexation Agreements to the agenda as item H.3. under new business. The motion was seconded by Alderman Pollock and carried by a voice vote.

PETITIONS AND COMMUNICATIONS

Roger Marcum, 1201A Silver Street, representing the Housing Authority of Champaign County, addressed the Council to express his disappointment in the Mayors of Champaign and Urbana for publicly criticizing the direction of and actions taken by, the

Board and the Directors of the Housing Authority of Champaign County.

Earl O'Shea, 606A South Glover Avenue, addressed the Council on the topic of better government. Mr. O'Shea stated that he appreciated the recitation of the Pledge of Allegiance and the appearance of Mayor Satterthwaite in the Fourth of July parade.

Alderman Whelan requested that a discussion of the possibility of one way traffic around Yankee Ridge School be put on the agenda of the next Traffic Commission meeting.

Alderman Singer stated that there is a serious problem in the Champaign/Urbana schools with respect to public safety and general deportment of young people getting along in school and relating to authority. Many people agree that simply adding more police officers will not solve the problem. Alderman Singer stated his disappointment in the lack of funds designated to solve the problem of child care and the human side of economic development, the maintenance of the civil society and the well educated labor force.

Alderman Singer suggested that this problem be discussed further at the Committee on Administration & Finance meeting on July 11, 1994.

OLD BUSINESS

There was none.

Committee on Administration and Finance

Alderman Pollock stated that the next meeting of the Committee on Administration and Finance will be Monday, July 11, 1994 at 7:30 p.m. at the Urbana City Building.

Committee on Environment and Public Safety

Alderman Singer moved A Resolution Authorizing The Mayors Of The City Of Champaign And The City Of Urbana To Execute The Local Government Statement For The Housing Authority Of Champaign County Comprehensive Plan on behalf of the Committee on Environment and Public Safety; no second is necessary.

Alderman Singer moved a substitute motion, A Resolution Authorizing The Mayor Of the City Of Urbana To Execute The Local Government Statement For The Housing Authority Of Champaign County Comprehensive Plan. (See attached.) The motion was seconded by Alderman Pollock and carried by a voice vote.

Alderman Singer moved to delete Section 2.b. and Section 2.e.4. The motion was seconded by a voice vote.

Alderman Whelan moved a substitute motion to delete 2a, 2b, and 2e items 1, 2, 3, 4 and 5. The motion was seconded by Alderman Taylor.

Following debate, Mayor Pro Tem Pollock took the Chair and Mayor Satterthwaite entered debate.

Following further debate, the substitute motion to delete

2a, 2b, and 2e items 1, 2, 3, 4 and 5 failed by 1-6 roll call vote.

Voting aye were Member of the Council: Whelan - 1; voting nay:
Hayes, Patt, Pollock, Ryan, Singer and Taylor - 6.

Mayor Satterthwaite resumed the Chair.

Following debate, Alderman Pollock moved to substitute to delete Section 2b only. The motion was seconded by Alderman Singer. The motion carried 4-3 by roll call vote. Voting aye were Members of the Council: Patt, Pollock, Ryan and Taylor - 4; voting nay: Hayes, Singer and Whelan - 3.

Alderman Singer moved to adopt An Ordinance Repealing The Urbana Local Traffic Ordinance And Adopting The Urbana Local Traffic Code. The motion was seconded by Alderman Hayes and carried 7-0 by roll call vote. Voting aye were Members of the Council: Hayes, Patt, Pollock, Ryan, Singer, Taylor and Whelan - 7; voting nay: none.

Alderman Singer moved to adopt An Ordinance Revising The Annual Budget Ordinance (CDBG). The motion was seconded by Alderwoman Ryan and carried 8-0 by roll call vote. Voting aye were Members of the Council: Hayes, Patt, Pollock, Ryan, Singer, Taylor, Whelan and Mayor Satterthwaite - 8; voting nay: none.

REPORTS OF SPECIAL COMMITTEES

There were none.

REPORTS OF OFFICERS

Mayor Satterthwaite reported that the work on the Library

is progressing and it will probably be open in about a week and a half.

Mayor Satterthwaite resumed the Chair.

Alderman Whelan moved to set the dates for public hearings for Flessner and Mathews annexations agreements for July 18, 1994 at 7:20 p.m. and 7:25 p.m. respectively. The motion was seconded by Alderwoman Ryan and carried by a voice vote.
