

**URBANA CITY COUNCIL MEETING**  
**Monday, February 2, 1998**

The City Council of the City of Urbana, Illinois met in regular session at 7:30 p.m., Monday, February 2, 1998 in the Urbana City Council Chambers at 400 South Vine Street.

There being a quorum, Mayor Satterthwaite called the meeting to order at 7:30 p.m.

Present at the meeting were Members of the Council: Hayes, Huth, Kearns, Patt, Taylor, Whelan and Wyman - 7; absent: none.

Also present were staff members: Police Chief Eddie Adair, Fire Division Chief Dave Newcomb, Bruce Walden, Jack Waaler, Bill Gray, April Getchius and Phyllis Clark.

**MINUTES OF PREVIOUS MEETING**

Alderman Wyman moved to approve the minutes of the January 20, 1998 regular meeting. The motion was seconded by Alderman Patt and carried by a voice vote.

**ADDITIONS TO THE AGENDA**

There were none.

**PETITIONS AND COMMUNICATIONS**

Eunice Buck, 1105 E. Oregon, addressed the Council regarding the recycling tax.

No. 9798-82: An Ordinance Amending Schedule I Of Section 5-2 Of The Urbana Local Traffic Code, As Amended, Establishing Speed Regulations On A Certain Portion Of Windsor Road (Susan Stone)**. The motion was seconded by Alderwoman Patt and carried 7-0 by roll call vote. Voting aye were Members of the Council: Hayes, Huth, Kearns, Patt, Taylor, Whelan, and Wyman - 7; voting nay: none.

Alderwoman Wyman moved to adopt **Res. No. 9798-R20: Resolution For Improvement By Municipality Under The Illinois Highway Code (Guardian Drive, Butzow Drive)**. The motion was seconded by Alderwoman Patt and carried 7-0 by roll call vote. Voting aye were Members of the Council: Hayes, Huth, Kearns, Patt, Taylor, Whelan, and Wyman - 7; voting nay: none.

Alderwoman Wyman moved to approve **Ord. No. 9798-83: An Ordinance Amending Section 15-1 Of The Urbana Local Traffic Code, Establishing A New Schedule O-1, And Designating An 80,000 Pound Truck Route (Guardian Dr., Butzow Dr.)**. The motion was seconded by Alderwoman Kearns and carried 7-0 by roll call vote. Voting aye were Members of the Council: Hayes, Huth, Kearns,

Patt, Taylor, Whelan, and Wyman - 7; voting nay: none.

Alderwoman Wyman moved to approve Ord. No. 9798-84: An Ordinance Revising The Annual Budget Ordinance (Fire Department Air Packs). The motion was seconded by Alderman Hayes and carried 8-0 by roll call vote. Voting aye were Members of the Council: Hayes, Huth, Kearns, Patt, Taylor, Whelan, Wyman, and Mayor Satterthwaite - 8; voting nay: none.

#### **REPORTS OF SPECIAL COMMITTEES**

Alderwoman Kearns stated that Steve Holz heard from Kathy Brabson, General Manager of Time Warner, that Time Warner Cable is willing to pay expenses that it is obligated to pay for the consultant on an on-going basis rather than at the completion of the process. There has been no final agreement between Time Warner and TCI.

#### **REPORTS OF OFFICERS**

Chief Administrative Officer Bruce Walden reminded Council and the public that Tuesday, February 3, 1998 the City will be testing the new sirens that have been installed in Urbana. This test will be conducted from 10:00 a.m. until noon.

Mr. Walden stated that the entire sequence of speeches from the Presidential visit will be run on the cable channel this evening.

Mr. Walden thanked Alderwoman Kearns for her compliments on the self-insured program and stated that the City had been able to save 2.5 million dollars with that program.
