Alderman Patt moved to adopt **Res. No. 1999-03-010R: Resolution For Improvement By Municipality Under The Illinois Highway Code (Streetlight Improvement Project – 3A)**. The motion was seconded by Alderman Hayes and carried 7-0 by roll call vote. Voting aye were Members of the Council: Hayes, Huth, Kearns, Patt, Taylor, Whelan and Wyman – 7; voting nay: none.

Alderman Patt moved to adopt **Res. No. 1999-03-011: Resolution Supporting Urbana School District #116 April 13, 1999 Tax Referendum Question**. The motion was seconded by Alderman Wyman and carried by a voice vote.

No. 1999-04-019: An Ordinance Approving A Preliminary And Final Plat Of Eastgate Subdivision No. 4 (Plan Case No. 1714-S-99)** stating that the Atkins Group has submitted a preliminary and final plat of Eastgate Subdivision No. 4 for Council approval. The property will be developed as single family attached or common lot line housing. There will be 49 new single-family attached homes.
