AN ORDINANCE AMENDING THE URBANA LOCAL TRAFFIC CODE  
(Restrictions on Lot 10B/Patrons of the Post Office)

WHEREAS, most postal service patrons require only a few minutes to utilize the services of the Post Office and it is in the best interests of the public that short-term parking be provided for those patrons; and

WHEREAS, there is ample parking provided for customers of Lincoln Square Mall and the Champaign County Courthouse in other lots and in the municipal parking deck,

THEREFORE, the Urbana City Council finds that it is in the public interest to restrict parking in municipal parking lot 10B to patrons of the U.S. Postal Service located nearby.

NOW THEREFORE, BE IT ORDAINED THAT the Urbana Local Traffic Ordinance is amended to add the following section:

“Sec. 23-177. Parking in municipal public parking lot designated as 10B is restricted to vehicles of patrons of the U.S. Postal Service facility located on the first floor of the Post Office building located at 202 South Broadway, while such persons are in the postal facility or going directly to or from their vehicles and the postal facility.”

The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
