# CITY COUNCIL MEETING Monday, July 3, 2000

The City Council of the City of Urbana, Illinois met in regular session at 7:30 p.m., Monday, July 3, 2000, in the Urbana City Council Chambers at 400 South Vine Street.

There being a quorum, Mayor Satterthwaite called the meeting to order at 7:35 p.m.

Present at the meeting were Members of the Council: Hayes, Huth, Kearns, Patt, Taylor, Whelan (arrived at 7:36 pm) and Wyman – 7; absent: none.

Also present were staff members: Police Chief Eddie Adair, Community Development Director April Getchius, Public Works Director Bill Gray, Assistant City Attorney Steve Holz and Chief Administrative Officer Bruce Walden.

# **MINUTES OF PREVIOUS MEETING**

Alderwoman Kearns moved to approve the minutes of the June 19, 2000 regular meeting. The motion was seconded by Alderwoman Wyman and carried by a voice vote.

# **ADDITIONS TO THE AGENDA**

Mayor Satterthwaite requested to add **A Resolution Expressing the Sense of the Council** as item number 4 under **NEW BUSINESS**. There were no objections.

# **PETITIONS AND COMMUNICATIONS**

Barbara Pritchard of 1317 East Florida, representing PACE, addressed the Council to invite Council Members and members of the community to upcoming anniversary celebrations of Americans with Disabilities.

Alderwoman Kearns mentioned that she has had many positive comments since the lights have come on at Vermont, Delaware, Florida and up around Carle Park. Alderwoman Kearns congratulated Mike Perkins and the entire Public Works Department for the work they have done.

Mayor Satterthwaite stated that Urbana has been awarded the Governor's Home Town

Award for its work in the mentoring program at Urbana High School and Urbana Middle School. Some of
those employees from the City of Urbana involved in that program are Barb Stiehl from the Public Works

Alderwoman Wyman moved to separate and first approve the reappointments to the Boards and Commission. The motion was seconded by Alderwoman Patt and carried by a voice vote.

Alderwoman Patt moved to approve the appointments to the Plan Commission, Helaine Silverman and Joseph Rank. The motion was seconded by Alderwoman Wyman and carried by a voice vote.

Alderwoman Wyman moved to approve the nominations for the Historic Preservation

Commission, Sharon Irish and William Rose. The motion was seconded by Alderwoman Patt and carried by a voice vote.

Alderwoman Kearns moved the appointment of Charlie Smythe to the Library Board. The motion was seconded by Alderman Hayes. Alderwoman Wyman requested to defer this appointment to a future Council meeting. The motion was seconded by Alderwoman Patt. Mayor Satterthwaite stated that this appointment would be on the agenda of the July 17, 2000 Council meeting.

Alderwoman Huth moved to enter into closed session for the purpose of discussing **probable litigation**. The motion was seconded by Alderwoman Patt and carried 7-0 by roll call vote. Voting aye were Members of the Council: Hayes, Huth, Kearns, Patt, Taylor, Whelan and Wyman – 7;

voting nay: none.

The Council entered into closed session at 8:15 p.m. and reconvened at 9:14 p.m. with all members previously in attendance still present.

Alderman Taylor moved to approve **Ordinance No. 2000-07-062**: **An Ordinance** Authorizing the Mayor to Take Certain Actions on Behalf of the City (Annexation Agreements). The motion was seconded by Alderman Whelan and carried 7-0 by roll call vote. Voting aye were Members of the Council: Hayes, Huth, Kearns, Patt, Taylor, Whelan and Wyman – 7; voting nay: none.

Alderwoman Kearns moved to adopt A Resolution Expressing the Sense of the **Council**. The motion was seconded by Alderwoman Wyman and carried by a voice vote.
