

ORDINANCE NO. 2001-09-102

AN ORDINANCE AMENDING THE SCHEDULE OF FINES  
PURSUANT TO SECTION 1-10(J)(1) OF THE URBANA CITY CODE

(Parking Meter Overtime and Street/Lot Overtime Fines)

WHEREAS, Section 1-10(j)(1) of the Urbana City Code provides that the fines for violation of the Urbana Local Traffic Code shall be established by the City Council and set forth in a schedule to be maintained by the City Clerk; and

WHEREAS, the City desires to change the fines for Meter Overtime and Street/Lot Overtime.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, THAT the Schedule of Fines set under Section 1-10(j)(1) of the Urbana City Code is hereby amended to read in accordance with the attached schedule.

The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.

### **Parking Violation Procedures and Penalties**

Article XVI, Section 23-211 (2) (d)

Article XVI, Section 23-214 (b)

Violation of any provision of the Urbana Local Traffic Code will subject the parking violator to a maximum fine of Two Hundred Fifty Dollars (\$250.00) per violation, which may be imposed if the City of Urbana elects to initiate collection proceedings through the judicial process.

### **Stopping, Standing or Parking Restricted or Prohibited On Certain Streets**

Article XIV, Section 23-192 (f) (2)

The display of a fraudulent parking permit shall carry a fine of not less than One Hundred Dollars (\$100.00) nor more than Two Hundred Dollars (\$200.00) per day.
