URBANA CITY COUNCIL MEETING JUNE 17, 2002

The City Council of the City of Urbana, Illinois, met in regular session Monday, June 17, 2002 in the Council Chambers at the Urbana City Building.

Mayor Satterthwaite called the meeting of the Urbana City Council to order at $7:34~\mathrm{p.m.}$

A. APPROVAL OF MINUTES OF PREVIOUS MEETING

[The following items were acted on together.]

2. June 3, 2002

Alderwoman Wyman made a motion to approve both sets of minutes (May 20, 2002 and June 3, 2002). Alderwoman Patt seconded.

Alderwoman Patt noted a word change on both sets of minutes. On page 6 of the May 20, 2002 minutes under section F.1.a, "Approval of Closed Session Minutes", the last word of the sentence where it reads "minutes" should be changed to "meetings". Thus, the sentence should

read: "Alderwoman Patt made a motion to approve the minutes of the following closed session *meetings*." The same change applies to the June 3, 2002 minutes in the first paragraph on page 1 under "Minutes of Previous Meeting". The very last line of that paragraph should read: "...minutes of the following closed session *meetings*."

There were no objections to changes made by Alderwoman Patt.

Alderwoman Chynoweth made a correction to page 3 of the May 20, 2002 minutes under "New Business". The second paragraph should state: "Alderwoman Chynoweth moved to approve Phase I..." The fifth paragraph, beginning with "Following debate...", should read: "Alderwoman Wyman offered a friendly amendment to also include that as a condition #6 that further special use permit review and approval be required for Phase II of the Church project as described in the site development plan, which it lists Phase I as the church, auditorium, offices, classrooms and the parking lot, and Phase II as the youth development center, recreation center, equipment building and ball field. Also, that the drainage and the detention basin and physical size of it be included as part of Phase I. Alderwoman Chynoweth accepted the friendly amendment."

There were no objections to changes made by Alderwoman Chynoweth.

The motion to approve the minutes of May 20, 2002 and June 3, 2002 carried by voice vote, as amended.

Timothy Ross (Senior Planner) presented the staff report. Gale Jameson (Assistant Public Works Director) was available to answer questions.

Following debate, Alderwoman Patt made a motion to approve the ordinance with a change to add a final "WHEREAS", which would read:

"WHEREAS, all existing curbs in the Myra Ridge and South Ridge Subdivisions, including the curbs on Myra Ridge south of Windsor Road, are mountable curbs and not barrier curbs.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. The request of waiver of subdivision regulations to allow the installation of mountable curb along Myra Ridge Drive instead of barrier curb required for such collector streets is approved.

Section 2. The request of waiver of subdivision regulations to allow Baronry Drive north of the site to be terminated in its current dead-end is denied."
