The requested vacation is part of the list of streets and alleys to be vacated per the agreement concerning the vacation of certain rights-of-way dated October 1, 2001. Following vacation of the street, the City would remove any city-owned parking meters, signs, etc., within the right-of-way. Staff recommends approval.

One-Half Feet in the City's R-1, Single-Family Residential Zoning District/705 W. Michigan Avenue –

Case No. ZBA-02-MAJ-8). Patrick Roberge and Ellen Deason have requested a major variance for the

construction of a detached accessory garage at 705 West Michigan Avenue. They propose to construct the

garage with side and rear yard setbacks less than those required in the Zoning Ordinance. Staff

Pollowing debate, Alderwoman Patt moved to approve Ordinance No. 2002-10-121: An Ordinance Approving a Major Variance (Reduction of the Required Five-Foot Side Yard Setback to One-and-One-Half Feet and Reduction of the Required Ten-Foot Rear Yard Setback to One-and-One-Half Feet in the City's R-1, Single-Family Residential Zoning District/705 W. Michigan Avenue – Case No. ZBA-02-MAJ-8). The motion was seconded by Alderman Hayes and carried 4-0-1. Voting aye

were Members of the Council: Chynoweth, Hayes, Otto, and Patt – 4; voting nay: none. Alderwoman Wyman abstained do to a conflict of interest.

Mayor Satterthwaite presented the **Library Bid Review**. Isaksen-Glerum's recommendation is to award the contract for expansion and remodeling of the Urbana Free Library to Roessler Construction of Rantoul. The base bid of \$5,938,600.00 lends itself to adding the three alternates to the contract at the onset, bringing the total under contract to \$6,042,000.00.

Following debate, Alderman Otto moved to award the contract for expansion and remodeling of the Urbana Free Library to Roessler Construction of Rantoul. The motion was seconded by Alderwoman Wyman and carried by a voice vote.
