RE: Ordinances from Traffic Commission

Attached are two ordinances for your approval from action taken by the Traffic Commission.

The first ordinance (Schedule H) is for the placement of stop signs at several locations. These stop signs are required due to the new O'Brien Drive at Cunningham Avenue street construction completed recently. The new O'Brien Drive and relocation of Anthony Drive in this area will increase the amount of traffic on the minor streets that intersect with the collector streets; therefore, these stop signs are needed and warranted under Section 2B-05 of the Manual on Uniform Traffic Control Devices. More specifically this warrant states that a stop sign may be warranted if one or more of the following conditions exist:

- 1. Intersection of a less important road with a main road where application of the normal right-of-way rule is unduly hazardous.
- 2. Street entering a through highway or street.
- 3. Unsignalized intersection in a signalized area.
- 4. Other intersections where a combination of high speed, restricted view, and serious accident record indicates a need for control by the STOP sign.

The conditions are met for numbers 1 and 2 above are met for all intersections in the ordinance.

The Traffic Commission has considered these locations at its July, 2002 meeting and recommends that the stop signs be installed.

The second ordinance (Schedule J) is for the extension of a no-parking zone previously approved on Sunset Drive east of Lincoln. The existing zone was extended approximately 45' to improve the maneuvering of vehicles near the intersection. One on-street space will be removed from Sunset Drive.

ORDINANCE NO. 2003-04-039

AN ORDINANCE AMENDING SCHEDULE H OF SECTION 23-93 OF THE URBANA LOCAL TRAFFIC CODE REQUIRING STOP SIGNS AT A CERTAIN INTERSECTION

(Vance Road at Northwood Drive, Vance Road at O'Brien Drive, O'Brien Drive at Vance Road, East Anthony Drive at O'Brien Drive)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule H of Section 23-93, entitled "Stop Signs Pursuant to Section 23-93", of Article VIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following intersections where drivers of vehicles shall be required to stop before entering the intersections:

Street	<u>Direction</u>	<u>Street</u>
Vance Road	Northbound	Northwood Drive
Vance Road	Northbound and Southbound	O'Brien Drive
O'Brien Drive	Eastbound	Vance Road
East Anthony Drive	Northbound	O'Brien Drive

<u>Section 2.</u> All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
