RE: Ordinance from Traffic Commission

Attached is an ordinance for City Council approval from action taken by the Traffic Commission.

The ordinance (Schedule H) is for the placement of stop signs at three locations. These stop signs are required due to the new construction of Saline Court in the North Lincoln Industrial Park Subdivision and the new Smith Road connection between Florida Avenue and Stone Creek Boulevard. The newly constructed streets intersect with the arterial/collector streets; therefore, these stop signs are needed and warranted under Section 2B-05 of the Manual on Uniform Traffic Control Devices. More specifically this warrant states that a stop sign may be warranted if one or more of the following conditions exist:

- 1. Intersection of a less important road with a main road where application of the normal right-of-way rule is unduly hazardous.
- 2. Street entering a through highway or street.
- 3. Unsignalized intersection in a signalized area.
- 4. Other intersections where a combination of high speed, restricted view, and serious accident record indicates a need for control by the STOP sign.

The conditions are met for numbers 1 and 2 above are met for all intersections in the ordinance.

The Traffic Commission has considered these locations at its August, 2004 meeting and recommends that the stop signs be installed.

ORDINANCE NO. 2004-08-110

AN ORDINANCE AMENDING SCHEDULE H OF SECTION 23-93 OF THE URBANA LOCAL TRAFFIC CODE REQUIRING STOP SIGNS AT A CERTAIN INTERSECTION

(Saline Court; Smith Road)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule H of Section 23-93, entitled "Stop Signs Pursuant to Section 23-93", of Article VIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following intersection where drivers of vehicles shall be required to stop before entering the intersection:

<u>Street</u>	Direction	<u>Street</u>
Saline Court	Eastbound	Lincoln Avenue
Smith Road	Northbound	Florida Avenue
Smith Road	Southbound	Stone Creek Boulevard

<u>Section 2.</u> All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.




PROPOSED STOP SIGN ON SALINE COURT AT LINCOLN AVENUE
