RE: Ordinances from Traffic Commission

Attached is an ordinance for your approval from action taken by the Urbana Traffic Commission.

The ordinance (Schedule H) is for the placement of stop signs on Cyprus Pointe at Stone Creek Boulevard, Stillwater Landing at Stone Creek Boulevard, Pebblebrooke Lane at Stone Creek Boulevard, Stonebrooke Court at Stone Creek Boulevard and Prairie Winds Drive at Colorado Avenue. The locations are in the Stone Creek and Prairie Winds subdivisions. These stop signs are required due to the resulting house construction in these areas that have increased the amount of traffic on the collector streets of Stone Creek Boulevard and Colorado Avenue; therefore, these stop signs are needed and warranted under Section 2B-5 of the Manual on Uniform Traffic Control Devices. More specifically, this warrant states that a stop sign may be warranted if one or more of the following conditions exist:

1. Intersection of a less important road with a main road where application of the normal right-of-way rule is unduly hazardous.
2. Street entering a through highway or street.
3. Unsignalized intersection in a signalized area.
4. Other intersections where a combination of high speed, restricted view, and serious accident record indicates a need for control by the STOP sign.

The conditions are met for numbers 1 and 2 above for all intersections.

The Traffic Commission has considered these locations at its October 2008 meeting and recommends that the ordinance be passed by the City Council.

AN ORDINANCE AMENDING SCHEDULE H OF SECTION 23-93 OF THE URBANA LOCAL TRAFFIC CODE REQUIRING STOP SIGNS AT A CERTAIN INTERSECTION

(Cyprus Pointe at Stone Creek Boulevard; Stillwater Landing at Stone Creek Boulevard; Pebblebrooke Lane at Stone Creek Boulevard; Stonebrooke Court at Stone Creek Boulevard; Prairie Winds Drive at Colorado Avenue)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule H of Section 23-93, entitled "Stop Signs Pursuant to Section 23-93", of Article VIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following intersections where drivers of vehicles shall be required to stop before entering the intersections:

Cyprus Pointe	Southbound	Stone Creek Boulevard
Stillwater Landing	Westbound	Stone Creek Boulevard
Pebblebrooke Lane	Southbound	Stone Creek Boulevard
Stonebrooke Court	Southbound	Stone Creek Boulevard
Prairie Winds Drive	Northbound	Colorado Avenue

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
