**SUBJECT: AN ORDINANCE APPROVING A SUBSTANTIAL AMENDMENT TO THE CITY OF URBANA AND URBANA/CHAMPAIGN/CHAMPAIGN COUNTY HOME CONSORTIUM CONSOLIDATED PLAN/ANNUAL ACTION PLAN FY 2008-2009 CDBG-R**

### **Description**

On the agenda of the May 26, 2009 Special Meeting of the Urbana City Council is an Ordinance Approving a Substantial Amendment to the Consolidated Plan/Annual Action Plan FY 2008-2009 CDBG-R. To receive Community Development Block Grant (CDBG-R), a one-time grant allocation to states and local entitlement communities as a result of the American Recovery and Reinvestment Act (ARRA), the City must substantially amend its FY 2008-2009 Annual Action Plan. The deadline for submission of the Substantial Amendment for CDBG-R to the Department of Housing and Urban Development (HUD) is **June 5, 2009**.

### **Issues**

The issue is whether the Urbana City Council should approve the Ordinance.

### **Background**

On March 18, 2009, HUD notified the City of its allocation of **\$125,097** of Community Development Block Grant funds (CDBG-R), as a result of the American Recovery and Reinvestment Act (ARRA). According to HUD, "Funding available under the Recovery Act has clear purposes – to stimulate the economy through measures that modernize the Nation's infrastructure, improve energy efficiency, and expand educational opportunities and access to health care."

The substantial amendment proposes to allocate the CDBG-R funding to the reconstruction of Green Street from Vine Street to Cottage Grove Avenue in Census Tract 55 of the City's Community Development Target Area. Using the funding for this project meets the stated purpose of the ARRA by modernizing infrastructure. The proposed Amendment is consistent with the Consolidated Plan goal of supporting infrastructure improvements in Urbana's

Community Development Target Area. Further, the project will have a positive economic impact by providing construction workers additional job opportunities for the upcoming construction season.

Using the CDBG-R funding for Green Street reconstruction, which is a “shovel-ready” project, meets the program guidelines to allocate funding to, “... give priority to projects that can award contracts based on bids within 120 calendar days from the date funds are made available to recipients; and that for infrastructure investments, recipients shall give preference to activities that can be started and completed expeditiously...” Bids for the project are expected to be advertised in late June and opened two weeks later. Substantial completion of the project is anticipated by mid-November 2009, within the prescribed timeline for expenditure of the CDBG-R funds.

To allow local governments to expedite the CDBG eligible projects, the regulations for CDBG-R waive the normal 30-day public comment period. However, grantees must make the proposed amendment available for public review and comment for a minimum period of seven (7) days prior to submittal to HUD. The draft of the Substantial Amendment was posted on the City website on May 13, 2009 and has been on display and available for public review and comment at the City Clerk’s office, the Department of Community Development Services office and the Urbana Free Library since May 14, 2009. In addition, a display advertisement was published in the *News-Gazette* on May 15, 2009. A public hearing will have been held on May 22, 2009 in City Council Chambers at 11:00 a.m. to complete the public review process.

## **Options**

1. Approve the Ordinance Approving a Substantial Amendment to the City of Urbana and Urbana/Champaign/Champaign County Home Consortium Consolidated Plan/Annual Action Plan FY 2008-2009 CDBG-R.
2. Approve the Ordinance with changes.
3. Do not approve the Ordinance.

## **Fiscal Impacts**

The proposed substantial amendment to the Annual Action Plan will provide an additional, one-time HUD grant of **\$125,097** in CDBG-R funding to the City. Using this funding for the Green Street project would reduce the total amount the City would need to expend on the project and potentially make funding available for other infrastructure improvement projects that benefit the target areas of the community.

## **Recommendations**

Staff recommends Council approve the Ordinance. At its May 19, 2009 Special Meeting, the seven members of the Urbana Community Development Commission (CDC) who were present at the meeting voted unanimously to forward the Ordinance to the Urbana City Council with a recommendation for approval (unapproved minutes attached).

The CDC also voted to, “recommend to City Council that the increased available City funds be utilized in the Community Development Target Area in a way consistent with the recent American Recovery and Reinvestment Act.”

WHEREAS, the City of Urbana has been designated an entitlement city under the Federal Housing and Community Development Act of 1974, as amended, and as such is eligible for Community Development Block Grant (hereinafter "CDBG") and Home Investment Partnership Funds (hereinafter "HOME") funds upon proper submittal being made to the United States Department of Housing and Urban Development (hereinafter "HUD"); and

WHEREAS, the Urbana City Council previously approved an ordinance authorizing submittal to HUD of the Annual Action Plan FY 2008-2009 that included proposed budgets for the CDBG and HOME Programs and HUD subsequently approved the said Annual Action Plan; and

WHEREAS, on May 13, 2009, the City of Urbana published on the City website a 7-day notice of a public review period and a notice of a public hearing regarding a proposed substantial amendment to the Annual Action Plan for FY 2008-2009; and

WHEREAS, on May 15, 2009 the City of Urbana published in the Champaign-Urbana News-Gazette a 7-day notice of a public review period and a notice of a public hearing regarding said proposed substantial amendment to the Annual Action Plan for FY 2008-2009; and

WHEREAS, on May 22, 2009, the City of Urbana, the Grants Management Division of the Community Development Services Department, held a public hearing on the proposed substantial amendment; and

WHEREAS, the City Council now finds it necessary and appropriate to substantially amend the City of Urbana and Champaign/Urbana/Champaign County HOME Consortium Annual Action Plan for FY 2008-2009.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the City of Urbana, as lead entity for the Urbana HOME Consortium, hereby approves the substantial amendment to the City of Urbana and Champaign/Urbana/Champaign County HOME Consortium Consolidated Plan/Annual Annual Action Plan for FY 2008-2009 CDBG-R, in substantially the same form as such amendment is referenced in the attachment hereto.

Section 2. That the Mayor of the City of Urbana is hereby designated as the authorized representative of the City of Urbana to take any action necessary in conjunction with said attached substantial amendment to the Consolidated Plan/Annual Action Plan, including submittal of the Annual Action Plan Amendment to the HUD Regional Field Office and provision of such additional information as may be required.

The American Recovery and Reinvestment Act of 2009 has allocated funds to states and local governments to carry out, on an expedited basis, eligible activities under the Community Development Block Grant (CDBG) program. As an entitlement city, the City of Urbana has been allocated \$125,097 of CDBG-R funds under the Recovery Act. Entitlement grantees are required to submit a substantial amendment to their FY 2008-2009 action plans in order to receive the allocation of CDBG-R recovery funds.

*This proposed Substantial Amendment has been prepared in accordance with the requirements provided in the publication: "Department of Housing and Urban Development [Docket No. FR-5309-N-01] Notice of Program Requirement for Community Development Block Grant Program Funding Under the American Recovery and Reinvestment Act of 2009."*

**Required elements in the CDBG-R substantial amendment to the annual action plan are:**

**1. A description of the activities the jurisdiction will undertake with these funds to address priority needs and objectives:**

The City of Urbana proposes to utilize its CDBG-R allocation for improvement of infrastructure in Census Tract 55 of the Community Development Target Area, specifically reconstruction of Green Street between Vine Street and Cottage Grove Avenue. This activity meets **Priority Objective # 1 – Provide a Suitable Living Environment** of the City's current Consolidated Plan. Following is a brief description of the project:

**Green Street – Street & Sidewalk Reconstruction**

CDBG-R funds will be contributed toward the reconstruction of Green Street from Vine Street to Cottage Grove, located in Census Tract 55 of the City of Urbana Community Development Target Area. Work will include milling and resurfacing of the street, reconstruction of (remove and replace) curb and gutter, brick and concrete sidewalks, ramps and driveway approaches.

Total CDBG-R Funding: \$125,097

Estimated Project Cost Total: \$845,000 - \$ 1,100,000

**2. Description of how the distribution and uses of the grantee's CDBG-R funds will meet the requirements of Title XII of Division A and Section 1602 of the Recovery Act:**

The City anticipates placing the project for bids on or around June 30, 2009. Bids are expected to be opened two weeks later (within 45-50 days of June 5, 2009, which is the date of submission of this amendment to HUD). Construction startup is anticipated by July 20, 2009, with substantial completion of the project expected by November 20, 2009.

**3. For each activity, a written description of how the use of CDBG-R funds for the activity will maximize job creation and economic benefit in relation to CDBG-R funds obligated, and will address the Recovery Act:**

After several continuous years of a high level of construction activity in the Urbana area, including infrastructure construction, the construction industry has been negatively impacted by the recent economic crisis. As a result, many construction workers in the area have experienced layoffs due to a reduction in available jobs. The City has had to re-evaluate its long range planning for infrastructure reconstruction and improvement. The long-term forecast is that some projects may be delayed due to lack of revenues. Utilizing CDBG-R funding for this project not only will provide immediate assistance for a much-needed improvement in a Target Area and employ construction workers, it is expected to have a positive ripple effect on future City projects in that more funding would be available for one or more future projects, thus continuing the construction employment opportunities.

**4. For each activity, the number of full- and part-time jobs estimated to be created and retained by the activity (including permanent, construction and temporary jobs):**

Jobs created by the proposed activity will be all construction related. The number created will depend on the number of workers already employed by the winning bidder. Contractors can retain current workforce members and re-hire former workers who were laid off due to lack of work. It is estimated that crews of 15-25 consisting of operators, laborers, teamsters, finishers and foremen will be working on this activity. In addition, it is likely that the general contractor will hire sub-contractor crews of 4-5 workers each for tree removal, pavement marking, trucking and landscaping, and miscellaneous activities. The total number of construction jobs provided by this activity is expected to range from 25 – 50.

**5. Description of the activities that will be carried out with CDBG-R funding that promote energy conservation, smart growth, and green building technologies, or reduced pollution emissions:**

This project will include the use of recycled concrete and recycled asphalt, which are green practices that save fuel and reduce greenhouse emissions when used instead of virgin product. This project is on a busline, promotes walkability, and follows in-town smart growth strategies.

**COMMUNITY DEVELOPMENT COMMISSION SPECIAL MEETING**  
**Tuesday, May 19, 2009, City Council Chambers**

**Call to Order:** Chairperson Cobb called the meeting to order at 7:02 p.m.

**Roll Call:** Connie Eldridge called the roll. A quorum was present.

**Commission Members Present:** Fred Cobb, Janice Bengtson, Chris Diana, Theresa Michelson, Jerry Moreland, Brad Roof, Dennis Vidoni

**Commission Members Absent:** Anne Heinze Silvis, George Francis

**Others Present:** John Schneider and Connie Eldridge, Community Development Services.

**Approval of Minutes:** *Chairperson Cobb asked for approval or corrections to the April 28, 2009 minutes. Commissioner Roof moved to approve the minutes, and Commissioner Bengtson seconded the motion. The motion carried unanimously.*

**Petitions and Communications:** None.

**Staff Report:** Mr. Schneider announced that Grants Management Division (GMD) staff had forwarded the Annual Action Plan (AAP) for Fiscal Year (FY) 2009-2010 to the Department of Housing and Urban Development (HUD) on May 14, 2009. The City of Urbana received additional federal funding of approximately \$6,700 in Community Development Block Grant (CDBG) and approximately \$117,000 in HOME Investment Partnership funds. Ten percent of the HOME funds were allocated to the Administration line item. The additional CDBG and balance of home funds are listed as unallocated. The HOME Technical Committee will decide how to use the balance of the HOME funds. HUD no longer provides funds for the American Dream Downpayment Initiative (ADDI) Program, the Technical Committee is considering using the extra HOME funds for a local first-time homebuyer assistance program. There has been an increase in requests for first-time homebuyer downpayment assistance.

Mr. Schneider briefly described HUD's CDBG-R regulations concerning the Proposed Substantial Amendment to the FY 2008-2009 AAP as a result of the American Recovery and Reinvestment Act (ARRA). HUD reduced the public comment period from 30 to 7 days for this amendment. Staff placed a notice on the City's website and published an ad in *The News-Gazette*. The Community Development (CD) Commission will discuss this amendment tonight, and the City Council will consider it at a Special Meeting on Tuesday, May 26, 2009. There will be a public hearing on Friday, May 22, 2009 at 11:00 a.m.

Mr. Schneider distributed a reminder for the Crystal View Townhomes groundbreaking ceremony on May 20, 2009 and a flyer for National Senior Health & Fitness Day on May 27. GMD staff attend community events and provide information on City programs.

City Council approved the transfer of 1107 and 1109 North Gregory Street to Homestead Corporation of Champaign Urbana. Also, Council approved the Ecological Construction Laboratory (e-co lab) and Homestead as Community Housing Development Organizations (CHDOs).

Referencing the sale of 1007 West Fairview Avenue, Mr. Schneider reviewed issues with the City's Land Use Agreement for properties that are donated to CHDOs. The Federal Home Administration (FHA) asked the City to waive this requirement. He reviewed the history of affordability periods on past projects. A land use restriction is a deed restriction. If a lender foreclosed on a property with this restriction, they could only sell the property to a low-income person. The City has asked the FHA to review this agreement and provide language that would make them comfortable. This requirement affects projects with Homestead, e-co lab, and Habitat for Humanity if they received lot donation from the City.

Commissioner Diana did not think FHA would accept any deed restrictions. Because each situation is different, blanket wording would not work. Mr. Schneider noted that the affordability period for HOME funds is waived with FHA loans. Otherwise, the City places a mortgage on a property for the period of affordability, typically five years.

**Old Business:** None.

**New Business:** **An Ordinance Approving a Substantial Amendment to the City of Urbana and Urbana/Champaign/Champaign County HOME Consortium Consolidated Plan/Annual Action Plan FY 2008-2009 CDBG-R** – Mr. Schneider stated the City has anticipated this since Congress passed the American Recovery and Reinvestment Act in February 2009. On March 18, 2009 HUD notified the City that it would receive a grant of \$125,097 in CDBG-R funding. Although certain regulations were waived, the City would have to amend its Annual Action Plan and follow a public information process.

The City is proposing to use the grant funds for reconstruction of Green Street from Vine Street to Cottage Grove Avenue in Census Tract 55. This project is "shovel-ready" and in the CD Target Area. Also, there had been earlier discussions about funding reconstruction of brick sidewalks in the same area. Even though the project was contemplated, the funding helps stimulate employment.

Mr. Schneider reviewed how the proposed amendment met program requirements. The project must be committed within 120 days after enactment of the Act. If the City does not submit by the June 5, 2009 deadline, the City could lose the funds. Using CDBG-R funds will help make City funds to be available for future projects. This project helps create and retain construction jobs, provides for energy conservation and follows smart-growth strategies. Because Section 3 regulations apply, contractors will be required to employ minority-owned and women-owned businesses and to hire low-income persons from the area.

Commissioner Roof inquired if the Green Street Reconstruction would have happened this year anyway. Mr. Schneider answered yes. Commissioner Roof asked about other shovel-ready projects, and Mr. Schneider noted this was the only project in the City's Target Area. City staff and the Mayor felt this was the best project for these funds. Instructions from HUD for these

funds encourages cities to invest funds in projects already planned and in process, and this project met that criteria.

Referencing the spirit of the ARRA, Commissioner Roof was concerned that this did not create anything that was not already planned. He asked if the CDBG funds displaced City funds. Mr. Schneider answered that it would make City funds available for other projects and mentioned the constricted timeline and HUD's regulations. Commissioner Roof wanted the City to spend its displaced funds within this year to fulfill the spirit of the recovery act. Mr. Schneider mentioned the possibility of moving up planned sidewalk reconstruction in the target area; however, another constraint is the workload of the City's Engineering Division.

Chairperson Cobb questioned whether the CD Commission would have any impact on how City funds were spent. Mr. Schneider did not believe so, especially if the funds came from the City's motor fuel tax or CIP funds. However, he would work with Public Works staff to get funds allocated for another CDBG eligible project, if possible.

In response to Chairperson Cobb, Mr. Schneider stated that City staff understands the need to work together to effectively produce infrastructure. The City uses a combination of funds and efforts to produce a positive outcome. It is understood that CDBG-R funds will have a ripple effect and produce construction jobs for future projects that may have otherwise been delayed.

In response to Commissioner Diana, Mr. Schneider confirmed the CDBG-R funds must be spent on shovel-ready projects, or the City may not receive the funds. Because this is not a large amount of funding, there is a limited scope. He clarified the City would place the project for bids on or around June 30, 2009.

Commissioner Vidoni enthusiastically endorsed this project's goal. He felt curb and street improvements in the area east of the City Building should be a high priority. That particular census tract appears to need more infrastructure improvements. Mr. Schneider mentioned creating an inventory of past CDBG infrastructure projects. For example, Census Tract 53 has had many CDBG infrastructure projects completed, the most recent being the Harvey Street improvements. The City of Urbana will be creating a new five-year Consolidated Plan, which will include infrastructure projects.

Commissioner Roof and Chairperson Cobb preferred to place the displaced funds in a standalone CD project. There was discussion whether City Council would approve this or if this was the way to go. Mr. Schneider mentioned constraints on Public Works staff. In addition, the City commits plans to commit CDBG funds to infrastructure projects in the CD Target Area. The Capital Improvement Plan (CIP) funding is the source of cash match for HOME funding.

Commissioner Diana suggested the CD Commission separate their request from the recommendation. The standalone request would be for City Council to seek an appropriate project to fund rather than tie it as a condition to CD's recommendation. Commissioner Roof felt it was more logical to tie the request to the recommendation. There was discussion on what information was provided to HUD.

Since this amendment would save City project funds, Chairperson Cobb stated the CD Commission would like to comment on how the City would use those “saved” funds. Commissioner Vidoni approved the amendment and suggested a resolution that the displaced funds be used for another project this fiscal year. There was discussion on the cost of the Green Street Reconstruction as compared to the amount of CDBG-R funds. Commissioner Michelson was concerned that the City would need to hire an engineering consultant for an additional project in order to meet such a deadline, thus reducing the amount for the project. Commissioner Roof felt this would still create jobs. If the project cost was higher than the minimum estimate, Commissioner Bengtson thought the CDBG-R funds might be needed to fill the gap.

Noting its advisory capacity, Mr. Schneider felt it was more in the purview of the CD Commission to make recommendations instead of providing requirements regarding use of such funds. Chairperson Cobb suggested using careful wording in a resolution.

Commissioner Diana stated the purpose of many projects is to create jobs and stimulate the economy. He assumed the City will spend these “saved” funds somewhere else in the City. It was irrelevant to him whether the City funds were spent in the CD Target Area. This was additional money that happened to funnel through this avenue, with the purpose of “getting the money out there.”

Referencing the economy, Commissioner Roof felt that the spirit was to stimulate, not just sustain, growth. Commissioner Vidoni felt City Council would, “take us at face value as an advisory body of reasonable people” who are making a recommendation. Chairperson Cobb added the CD Commission is an independent body with its own mind. Although the CD Commission may not always say things that are comfortable for City Council, the Commission “says things that are reasonable.”

In response to Commissioner Moreland, Mr. Schneider stated the CD Target Area is based on U.S. Census results. The Target Area has 51% or more of households at or below 80% of Median Family Income (MFI).

There was discussion about the City using minority-owned and female-owned businesses in this project. Mr. Schneider noted that Section 3 and Davis Bacon requirements must be reported to HUD. Chairperson Cobb requested a list of minority and female contractors whom the City has identified for this project. Mr. Schneider said that the City had not identified any at this point as that is part of the bid process. However, he will request that information regarding potential sub-contractors from the Engineering Division.

*Commissioner Vidoni moved to recommend to City Council approval of an Ordinance Approving a Substantial Amendment to the City of Urbana and Urbana/Champaign/Champaign County HOME Consortium Consolidated Plan/Annual Action Plan FY 2008-2009 CDBG-R. Commissioner Bengtson seconded the motion, and the motion carried unanimously.*

*Referencing the Substantial Amendment for FY 2008-2009 CDBG-R funds, Commissioner Vidoni made the following motion: That the Community Development Commission resolve to recommend that displaced funds be utilized as a standalone project to be committed during this fiscal year. Commissioner Roof seconded the motion.*

There was discussion as to the wording and intent of the motion. Commissioner Michelson questioned why this should be a standalone project and why it should be limited to \$125,097. Chairperson Cobb noted this seemed to be the first preference of the CD Commission, but agreed it could be used as part of another project. Commissioner Bengtson mentioned the potential of problems in finding an appropriate standalone project.

Commissioner Roof preferred creating a new project that did not exist in any current plans. Noting the City Engineering Division has long range plans for the next 10-15 years, Commissioner Michelson felt that creating a totally new project was not an efficient use of City government. Commissioner Roof suggested funding a project that did not require additional engineering, but would provide stimulus and meet the spirit of the ARRA recommendation. An example would be paying for curbs on another street. Commissioner Moreland asked if there were any projects that could be “shovel ready” next spring. Commissioner Bengtson preferred the funds stay in the CD Target Area.

Commissioner Diana remarked the CD Commission was asking City Council to act in the spirit of the ARRA. He noted a generic request was easier to fulfill. There was discussion on whether to describe the City funds as “displaced budgeted money.” Mr. Schneider suggested the wording “increased available City funds.” Because the City of Urbana’s budget for next fiscal year is in the process of being approved, Mr. Schneider did not know how this would be handled. Also, it is possible that HUD may not approve this amendment, in which case the City would have to revise and resubmit its application. Commissioner Roof asked if HUD would view the City’s application less favorably due to the additional resolution. Mr. Schneider did not know.

Rather than refer to the federal stimulus bill, Commissioner Diana suggested using “American Recovery and Reinvestment Act.” Commissioner Vidoni agreed.

*Commissioner Vidoni modified his motion: That the Community Development Commission resolve to recommend to City Council that the increased available City funds be utilized in the Community Development Target Area in a way consistent with the recent American Recovery and Reinvestment Act. The motion carried unanimously.*

**Adjournment:** Commissioner Michelson moved to adjourn the meeting, and Commissioner Diana seconded the motion. Chairperson Cobb adjourned the meeting at 8:10 p.m.
