RE: Ordinance from Traffic Commission

Attached is an ordinance for your approval from action taken by the Urbana Traffic Commission.

The ordinance (Schedule J) prohibits parking at all times on the west side of Division Avenue, the north side of Stebbins Drive, at certain locations on the east side of Division Avenue, and at certain locations on the south side of Stebbins Drive. These streets are newly-constructed, paved streets (28 feet in width) that provide access to parking behind the residences in the Crystal View subdivision. Since the intersection of Division Avenue and Stebbins Drive is controlled by a traffic roundabout, parking restrictions are recommended on the south side of Stebbins Drive and on the east side of Division Avenue to improve traffic flow approaching the roundabout. The developers of the subdivision worked with the City to determine the locations of these parking restrictions.

The Traffic Commission has considered these locations at its November 2009 meeting and recommends that the ordinance be passed by the City Council.

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Division Avenue, Stebbins Drive)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

Division Avenue	From the centerline of Stebbins Drive to 580 feet north of the centerline of Stebbins Drive	West Side
Division Avenue	From the centerline of Stebbins Drive to 240 feet north of the centerline of Stebbins Drive	East Side
Stebbins Drive	From the centerline of Broadway Avenue to 1,040 feet east of the centerline of Broadway Avenue	North Side
Stebbins Drive	From the centerline of Broadway Avenue to 150 feet east of the centerline of Broadway Avenue	South Side

Stebbins Drive From 470 feet east of South Side
the centerline of
Broadway Avenue to 810
feet east of the centerline
of Broadway Avenue

Stebbins Drive From 990 feet east of South Side
the centerline of
Broadway Avenue to 1,040
feet east of the centerline
of Broadway Avenue

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

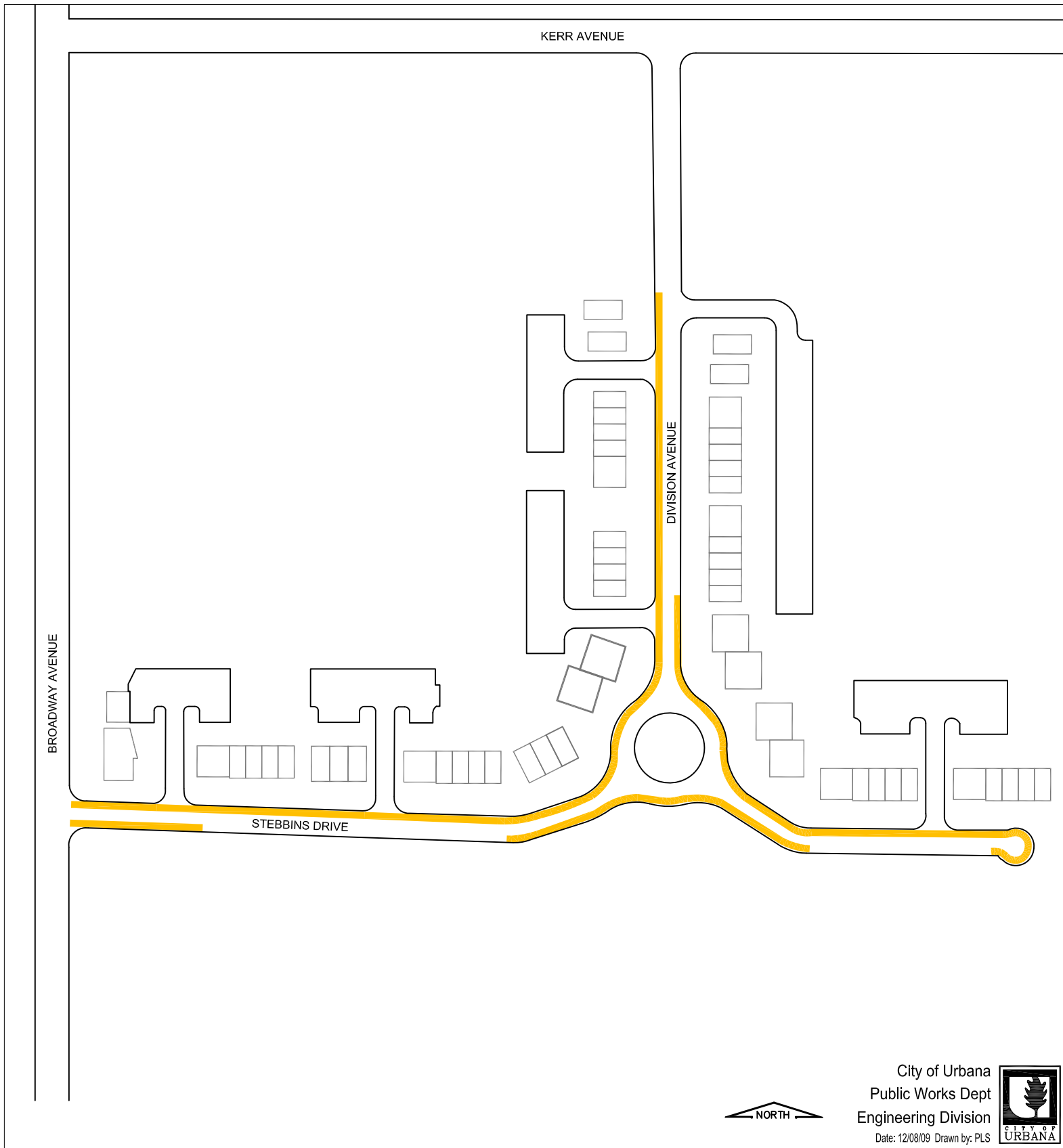
