**RE: Ordinance from Traffic Commission**

Attached is an ordinance for your approval from action taken by the Urbana Traffic Commission.

Recently, the property owners at 1002 South Busey Avenue widened their driveway approach on the south side of Iowa Street east of Busey Avenue. This widening required relocating the existing parking space near the driveway 14 feet to the west. The ordinance removes the parking restrictions that applied to the old location of the parking space so that the new space will be in conformance.

The Traffic Commission has considered this location at its August 2010 meeting and recommends that the ordinance be passed by the City Council.

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Iowa Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by DELETING from that schedule the following portion of a street where no person shall park a vehicle at any time:

<u>Street</u>	<u>Between</u>	<u>Side of Street</u>
Iowa Street	From 90 feet east of the centerline of Busey Avenue to 104 feet east of the centerline of Busey Avenue	South Side

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance

shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
