AN ORDINANCE APPROVING A SECOND AMENDMENT TO A CITY

OF URBANA COMMUNITY DEVELOPMENT BLOCK GRANT AGREEMENT [Center for Women in Transition-Domestic Violence Program (formerly A Woman's Place)], Project No. 1011-AAP-01)

Description

Included on the agenda of the July 11, 2011 Urbana City Council meeting is an ordinance approving a second amendment to the City of Urbana Community Development Block Grant (CDBG) Agreement Center for Women in Transition-Domestic Violence Program, Project No. 1011-AAP-01). The approval of the proposed amendment would extend the timeline for completing this project from June 30, 2011 to August 31, 2011.

Issues

The issue is whether the Urbana City Council should approve the ordinance approving the proposed second amendment to this agreement.

Background

On April 19, 2010, the Urbana City Council passed Ordinance No. 2010-04-024 approving the City of Urbana and Urbana HOME Consortium Annual Action Plan FY 2010-2011, which included funding to A Woman's Fund (AWF) for the repair of the foundation, installation of proper drainage and grading on the grounds, and installation of a new HVAC system at the shelter operated by A Woman's Place (AWP).

On July 1, 2010, Center for Women in Transition (CWT) and A Woman's Fund (AWF) merged, due to the financial crisis caused by the lack of payments to AWF from the State of Illinois. A Woman's Fund, the umbrella organization over AWP, was dissolved and AWP then became a part of CWT, who reorganized and designated AWP as their domestic violence program. On July 19, 2010, the Urbana City Council passed Ordinance No. 2010-07-061 approving the agreement between the City of Urbana and Center for Women in Transition for the project.

On January 21, 2011 the City of Urbana received a letter from John Sullivan, Executive Director, at the Center for Women in Transition requesting the grant funds be used for a different project at the same location, as the original project of drainage and site grading had been completed through donations. The revised scope of work involved the renovation of the kitchen at the shelter. The amendment to the agreement, which changed the scope of work, was then approved by the Urbana City Council, via Ordinance No. 2011-04-024, on April 18, 2011, and executed by the Mayor on May 17, 2011.

On June 24, 2011 the City of Urbana received an email from John Sullivan, Executive Director at the Center for Women in Transition, requesting that the activity be extended until August 31, 2011, as the length of time in the process for executing the first grant amendment, and for when the Invitation to Bid was able to be published in the newspaper, did not allow enough time for the project to be completed by the June 30, 2011 deadline.

At its June 28, 2011 regular meeting, the Urbana Community Development Commission voted unanimously to forward the ordinance to the Urbana City Council with a recommendation for approval.

Options

- 1. Approve the ordinance approving the second amendment with Center for Women in Transition.
- 2. Approve the ordinance approving the second amendment, with suggested changes.
- 3. Do not approve the ordinance approving the second amendment.

Fiscal Impacts

This amendment would not have any direct fiscal impact as these monies have been previously budgeted. Changing the length of time for completion will not have a negative impact on the City's timely expenditure of CDBG funds, as the project should be completed before the next required timeliness test by HUD.

Recommendations

Staff and the Community Development Commission recommend that the Urbana City Council approve the ordinance authorizing the execution of the second amendment to the agreement.

AN ORDINANCE APPROVING A SECOND AMENDMENT TO A CITY OF URBANA COMMUNITY DEVELOPMENT BLOCK GRANT AGREEMENT

[Center for Women in Transition - Domestic Violence Program (formerly A Woman's Place),
Project No. 1011-AAP-01]

WHEREAS, on April 19, 2010, the Urbana City Council passed Ordinance
No. 2010-04-024 approving the City of Urbana and Urbana HOME Consortium
Annual Action Plan FY 2010-2011.

WHEREAS, on July 1, 2010, the Center for Women in Transition (CWT) and A Woman's Fund, the umbrella organization over A Woman's Place, merged, and A Woman's Place became a program under the Center for Women in Transition.

WHEREAS, On July 19, 2010, the Urbana City Council passed Ordinance No. 2010-07-061 approving the agreement, which provided Thirty-One Thousand Eight Hundred Forty-Six and 00/100 dollars (\$31,846.00) in Community Development Block Grant (CDBG) funds towards the repair of the foundation, installation of proper drainage and grading on the grounds, and installation of a new HVAC system, at the domestic violence shelter (formerly A Woman's Place) operated by the Center for Women in Transition.

WHEREAS, on January 19, 2011, the Center for Women in Transition sent a letter to the City of Urbana requesting to amend the Community Development Block Grant (CDBG) Agreement in order to revise the scope of work to the renovation of the kitchen at the domestic violence shelter operated by the Center for Women in Transition; and

WHEREAS, on March 29, 2011, the Community Development Commission unanimously voted to forward the Ordinance approving the proposed amendment to the agreement to the Urbana City Council for approval.

WHEREAS, on April 18, 2011, the Urbana City Council approved the ordinance approving the proposed amendment to the agreement. On May 17, 2011, the amendment to the grant agreement was then executed by the Mayor.

WHEREAS, on June 13, 2011, the Center for Women in Transition contacted the City of Urbana, via email, requesting to extend the deadline for completion of the project, and

WHEREAS, the City and Center for Women in Transition now desire to amend the Community Development Block Grant (CDBG) Agreement to revise the length of time for completion of the renovation of the kitchen at the domestic violence shelter operated by the Center for Women in Transition from June 30, 2011 to August 31, 2011;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the City of Urbana hereby approves A SECOND AMENDMENT TO A CITY OF URBANA COMMUNITY DEVELOPMENT BLOCK GRANT AGREEMENT (CENTER FOR WOMEN IN TRANSITION-DOMESTIC VIOLENCE PROGRAM, PROJECT NO. 1011-AAP-01), a copy of which is attached hereto and incorporated herein by reference, and authorizes the Mayor of the City of Urbana to execute the same on behalf of the City of Urbana.

Section 2. That the Mayor of the City of Urbana, Illinois, be and the same is hereby authorized to execute and deliver and the City Clerk of the City of Urbana, Illinois, be and the same is authorized to attest to said execution of said Agreement as so authorized and approved for and on behalf of the City of Urbana, Illinois.

This CDBG Agreement is made this _____day of July 2011 between the City of Urbana, an Illinois Municipal Corporation (hereinafter referred to as the "City"), and <u>Center for Women in Transition</u>, an Illinois Not-For-Profit Organization (hereinafter referred to as the "Subgrantee").

WITNESSETH:

WHEREAS, the City has been designated as an "Entitlement" by the U. S. Department of Housing and Urban Development under provisions of the Housing and Community Development Act of 1974, as amended, and the City has received an entitlement of funds during the period July 1, 2010 - June 30, 2011, pursuant to the Community Development Block Grant Program (hereinafter referred to as the "CDBG Program"); and

WHEREAS, the Urbana City Council adopted a CDBG Program and budget which authorized funding for the repair of the foundation, installation of proper drainage and grading on the grounds, and installation of a new HVAC system, at the domestic violence shelter (formerly A Woman's Place) operated by Center for Women in Transition, located at 1304 East Main Street, Urbana; and

WHEREAS, the City has the right and authority under said CDBG Program to change the amount of funds allocated for CDBG Agreements; and

WHEREAS, on April 19, 2010, the Urbana City Council passed Ordinance No. 2010-04-024 approving the <u>City of Urbana and Urbana HOME Consortium Annual Action Plan for Program Year 2010-2011.</u>

WHEREAS, on January 21, 2011, the City of Urbana received a letter from the Center for Women in Transition requesting a change in the scope of work at the domestic violence shelter, to use the funds to renovate the kitchen instead of repairing the foundation, as the original work was completed due to a donation from a contractor.

WHEREAS, on March 29, 2011, the Community Development Commission unanimously voted to forward the ordinance approving the proposed amendment to the Urbana City Council for approval.

WHEREAS, on April 18, 2011, the Urbana City Council approved the ordinance approving the proposed amendment to the agreement. On May 17, 2011, the amendment to the grant agreement was then executed by the Mayor.

WHEREAS, on June 13, 2011, the Center for Women in Transition has requested a change in the completion date of the project to renovate the kitchen from June 30, 2011 to August 31, 2011.

NOW, THEREFORE, for and in consideration of the premises and of the mutual covenants and agreements herein contained, the parties agree as follows:

- 1. The Subgrantee represents to the City that the Project shall now terminate on August 31, 2011.
- 2. All other provisions of said CDBG Agreement shall remain in full force and effect.
