**RE: Ordinance from Traffic Commission**

Attached is an ordinance for your approval from action taken by the Urbana Traffic Commission on July 26, 2011.

The ordinance (Schedule J) prohibits parking at all times at certain locations on the south side of Kettering Park Drive and east side of Linview Avenue.

Currently, parking is prohibited on the north side of Kettering Park Drive and west side of Linview Avenue. Both streets end at this intersection so the street forms a curve at this location. Driveways into the A&R complex are located at the south end of the intersection and along the east side of Linview Avenue within 90 feet of the intersection. Employees of A&R use Kettering Park Drive and Linview Avenue for overflow parking. At times, cars are parked within the curve of Kettering Park Drive and Linview Avenue creating problems for busses and large trucks as they maneuver around the curve. Parking restrictions would allow more room for these vehicles to safely travel around the curve and for A&R employees to see traffic as they leave the A&R parking lots.

The Traffic Commission recommends that the attached ordinance be passed by the City Council.

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Kettering Park Drive; Linview Avenue)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

<u>Street</u>	<u>Between</u>	<u>Side of Street</u>
Kettering Park Drive	From the centerline of Linview Avenue to 60 feet west of the centerline of Linview Avenue	South Side
Linview Avenue	From the centerline of Kettering Park Drive to 90 feet north of the centerline of Kettering Park Drive	East Side

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the

effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
