H. REPORTS OF OFFICERS

William Gray (Public Works Director) invited the Council members to ride along with a snow plow driver sometime during the season to get an idea of the job requirements.

Michael Dilley (Fire Chief) told of a recent call where the resident had accidentally set off his medic alert button by mistake. However, while the fire staff checked the alarm out, they discovered a more serious problem of a gas leak in the basement. They corrected the problem and got the resident to safety until his home could be cleared of the gas fumes and the leak stopped.

Mayor Prussing announced the Police Department staff and Swat Team members were recently involved in a situation on December $12^{\rm th}$ which ended with several suspects being taken into custody. She also mentioned she forwarded to Council the rules and procedures for Council meetings for their review.

Elizabeth Tyler (Community Development Director) announced Staff had received good responses back from citizens whose homes are being included on the listing of 100 most important buildings in Urbana. Information and photos received are now being compiled by staff.

I. NEW BUSINESS

1. Ordinance No. 2011-12-138: An Ordinance Approving a Collective Bargaining Agreement with Local 1147 of the International Association of Fire Fighters (Term of July 1, 2011 through June 30, 2013)
