RE: Second Amendment to Agreement for use of Right-of-Way, Windstream KDL, Inc.

INTRODUCTION

On May 16, 2011 the City Council approved and the Mayor executed a license agreement with Windstream KDL, Inc. of Overland Park, Kansas to authorize the installation of fiber optic cables both above ground on Ameren power poles and below ground in conduits within the rights-of-way of the City. The proposed routing of the fiber optic cable was depicted in Exhibits A, B and C to the license agreement. During the installation of the fiber optic cable it became necessary to change the routing such that a portion of the installation fell outside the limits defined in the Exhibit A to the license agreement. A first amendment to the agreement to substitute a revised Exhibit A, dated July 26, 2011, was passed by Council August 1, 2011. Windstream wishes to install additional fiber optic cable on the south side of West Kenyon Road west of Lincoln Avenue, the west side of North Lincoln Avenue between West Kenyon Road and Bradley Avenue and the north side of West Bradley Avenue between Lincoln Avenue and Goodwin Avenue. The location of the proposed installation is shown in Exhibit D, included in the proposed attached Second Amendment to the aforementioned May 16, 2011 license agreement.

FISCAL IMPACT

The proposed installation of the additional fiber optic conduit/cable is at no cost to the City.

RECOMMENDATION

It is recommended that the City Council approve AN ORDINANCE APPROVING A SECOND AMENDMENT TO AN AGREEMENT FOR USE OF RIGHT-OF-WAY BETWEEN THE CITY OF URBANA AND WINDSTREAM KDL, INC. (West Kenyon Road, Lincoln Avenue and Bradley Avenue)

AN ORDINANCE APPROVING A SECOND AMENDMENT TO AN AGREEMENT FOR USE OF RIGHT-OF-WAY BETWEEN THE CITY OF URBANA AND WINDSTREAM KDL, INC.

(Kenyon Road, Lincoln Avenue and Bradley Avenue)

WHEREAS, the parties hereto did on the 16th of May 2011, pursuant to Ordinance No. 2011-04-031, enter into an agreement to allow Windstream KDL, Inc. ("Windstream") to install fiber optic cables both above ground and below ground within the certain rights-of-way of the City of Urbana ("City"); and

WHEREAS, Windstream and the City have determined that the best interests of both entities are served by making and entering into an amendment to said agreement to authorize an additional construction boundary for the West Kenyon Road, Lincoln Avenue and Bradley Avenue rights-of-way.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Urbana, Champaign County, Illinois, as follows:

Section 1.

The amendment to the prior agreement, as reflected in the attached agreement entitled: "Second Amendment to an Agreement for Use of Right-Of-Way between the City of Urbana and Windstream KDL, Inc. (West Kenyon Road, Lincoln Avenue and Bradley Avenue)" is hereby authorized and approved.

This Second Amendment shall take effect upon execution by the City and the Company.


This Second Amendment will be recorded in the Office of the Champaign County Recorder of Deeds at the expense of the City.
