**RE:** An Ordinance Amending Schedule J of Section 23-172 of the Urbana Local Traffic Code Establishing Curb Loading Zones on Certain Streets (801 East Florida Avenue)

**Introduction**

Attached is an ordinance for approval from action taken by the Urbana Traffic Commission at its October 2, 2018 meeting. A location map showing the area of the proposed action is included.

**Background**

At the Urbana Committee of the Whole meeting held on Monday, October 22, 2018, the committee recommended sending this ordinance to the Urbana City Council with an amendment that would require a review of the loading zone designation five years following the approval of the ordinance.

**Recommendation**

It is recommended that Council approve an Ordinance Amending Schedule J of Section 23-172 of the Urbana Local Traffic Code Establishing Curb Loading Zones on Certain Streets (801 East Florida Avenue) as amended.

**ORDINANCE NO. 2018-10-071**

**AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-172 OF THE URBANA LOCAL TRAFFIC CODE ESTABLISHING CURB LOADING ZONES ON CERTAIN STREETS**

**(801 East Florida Avenue)**

**WHEREAS**, the City of Urbana (“Urbana”) is an Illinois Municipal Corporation pursuant to the Illinois Constitution of 1970 and the Statutes of the State of Illinois;

**WHEREAS**, the City of Urbana has adopted a local traffic code which is set forth in its ordinances as Section 23-1 *et seq.*; and

**WHEREAS**, the City of Urbana, pursuant to the aforesaid traffic code, has the authority to regulate locations marked as curb loading zones on its streets and in its parking lots; and

**WHEREAS**, the City of Urbana regulates loading zones on streets to provide public safety and access;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS**, as follows:

Section 1. That Schedule J of Section 23-172, entitled "Standing in Curb Loading Zones" of Article XIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that Schedule the following portion of a street, which shall be established as a loading zone on the designated days or times:

<u>Street</u>	<u>Direction</u>	<u>Days</u>	<u>Hours</u>	<u>Duration</u>
Florida Avenue from 90 feet west of the centerline of Wiley Drive to 132 feet west of the centerline of Wiley Drive	Eastbound	Monday through Friday	7 a.m. to 6 p.m.	15 minutes

Section 2. That the Traffic Engineer is hereby authorized and directed to post the appropriate signs indicating the location of the loading zone as set forth in this Ordinance and to conduct a review of the location within five years from the date of Council approval.

Section 3. That the Traffic Engineer is hereby authorized and directed to remove the signs indicating said loading zone if the review indicates the need for the loading zone no longer exists.

Section 24. Those sections, paragraphs, and provisions of the Urbana City Code that are not expressly amended or repealed by this Ordinance are hereby re-enacted, and it is expressly declared to be the intention of this Ordinance not to repeal or amend any portions of the Urbana City Code other than those expressly set forth as amended or repealed in this Ordinance. The invalidity of any section or provision of this Ordinance hereby passed and approved shall not invalidate other sections or provisions thereof.

Section 53. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 46. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

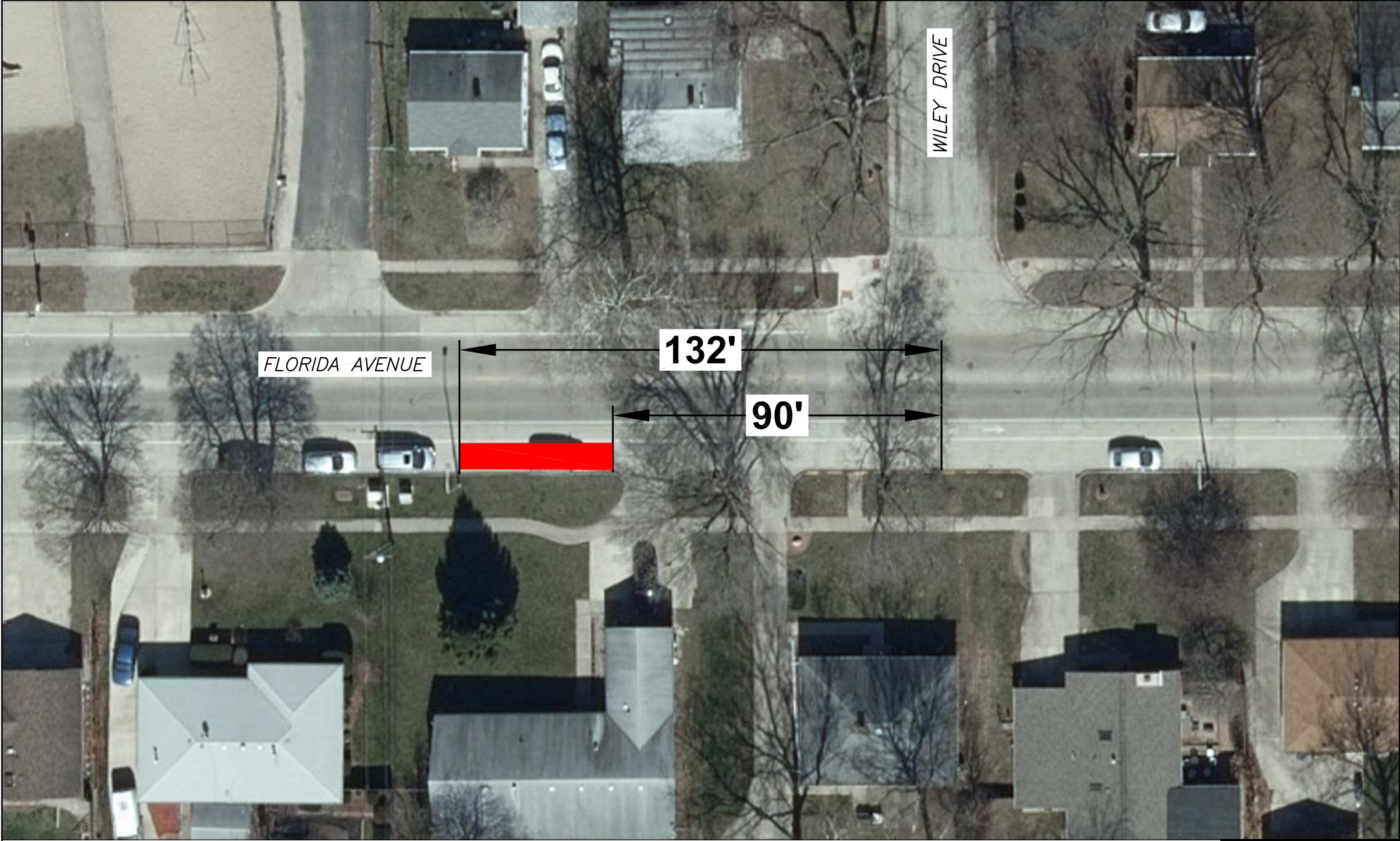
