A Resolution Approving the Civilian Police Review Board (CPRB) Orientation, Technical

Training, and Continuing Education Standards

Introduction: City staff are working collaboratively with the CPRB members to ensure that the CPRB Ordinance is being administered and implemented as the City Council intended when the CPRB was established in 2007 (and reauthorized and/or amended in 2009, 2011, and 2015). To that end, approval of this Resolution is sought to comply with Section 19-23 of the CPRB Ordinance.

Discussion: Section 19-23 (Training and Orientation) of the CPRB Ordinance reads as follows:

The human relations office (HRO) shall develop written standards for orientation and continuing education for all CPRB members. The written standards shall be subject to the approval of the Mayor and the Council. Completion of the orientation program is required before a member is seated. Timely completion of continuing education is required for all sitting members.

In order to ensure that new Board members can begin their work on the CPRB as quickly as possible, the orientation and training have been divided into two parts: orientation and technical training. Outlines of the subject matter for each of these types of training are attached, along with approximate time durations. With Council approval, the orientation would be required for each member to be seated; the technical training would be required within the first six months of being appointed (although we would try to complete it sooner than that).¹

The annual continuing education standards would become effective in the calendar year after a given member is initially seated in order to allow time for the Board member to receive the orientation and technical training.

Recommendation: Staff recommends that the City Council approve the attached orientation, technical training, and continuing education standards for the CPRB with any required modifications.

¹ For current Board members, all Board members will take the Orientation prior to their next regular meeting on July 22, 2020 to ensure that they all meet the requirement of Section 19-23. Further, all Board members will take the technical training between now and the end of calendar year 2020, with the exception of the ride-along requirement. Until the State of Illinois is in Phase 5 of Restore Illinois (or more solidly within Phase 4), ride-alongs have been suspended.

A RESOLUTION APPROVING ORIENTATION, TECHNICAL TRAINING, AND CONTINUING EDUCATION STANDARDS FOR CIVILIAN POLICE REVIEW BOARD MEMBERS

WHEREAS, the City of Urbana ("City") is a home rule unit of local government pursuant to Article VII, Section 6, of the Illinois Constitution, 1970, and may exercise any power and perform any function pertaining to its government and affairs, and the passage of this Resolution constitutes an exercise of the City's home rule powers and functions as granted in the Illinois Constitution, 1970; and

WHEREAS, in 2007, the Mayor and City Council determined that a civilian police review board would enhance public safety by providing an independent means to review citizen complaints regarding police officer conduct and the operations of the Urbana Police Department; and

WHEREAS, on August 6, 2007, the City Council approved Ordinance No. 2007-07-085, amending Urbana City Code Chapter 19 to establish the Civilian Police Review Board (CPRB); and

WHEREAS, on April 20, 2009, the City Council approved Ordinance No. 2009-04-036 to reauthorize the CPRB; and

WHEREAS, on May 16, 2011, the City Council approved Ordinance No. 2011-05-034 to amend and reauthorize the CPRB Ordinance; and

WHEREAS, on February 2, 2015, the City Council approved Ordinance No. 2015-01-003 to expand the authority of the CPRB to include oversight of the display and use of TASERs by the Urbana Police Department; and

WHEREAS, each time the CPRB Ordinance was approved, amended, or reauthorized, it included Urbana City Code Chapter 19, Article III, Division 1, Section 19-23, requiring in part that the Human Relations Office develop written standards for orientation and continuing education for all CPRB members, subject to the approval of the Mayor and City Council; and

WHEREAS, City staff, in collaboration with CPRB members, have developed orientation, technical training, and continuing education standards to present to the Mayor and City Council for their approval; and

WHEREAS, the City Council, after due consideration, finds that approving such orientation, technical training, and continuing education standards as herein provided is in the best interests of the residents of the City and is desirable for the welfare of the City's government and affairs.

¹ This requirement is waived during the calendar year in which a given CPRB member is seated for the first time, to allow for the Orientation and Technical Training Standards to be met.
