RE: An Ordinance Amending Schedule J of Section 23-172 of the Urbana Local

Traffic Code Establishing Curb Loading Zone on Certain Streets (Clark Street)

Introduction

Attached are ordinances and maps for approval from action taken by the Urbana Traffic Commission at its March 3, 2021, meeting.

Background

The ordinance amends Schedule J of the Urbana Local Traffic Code by adding a 15-minute loading zone designation on Clark Street in a bump-in along the north side of Clark Street adjacent to the Gather Development's north building. The designation and bump-in will provide a way for any vehicle that is loading/unloading to be removed from the flow of traffic and create a safer environment for all during the process.

The Traffic Commission recommended the establishment of a loading zone designation on Clark Street to be sent to Council for consideration.

Recommendation

It is recommended that Council approve an Ordinance Amending Schedule J of Section 23-172 of the Urbana Local Traffic Code Establishing Curb Loading Zones on Certain Streets (Clark Street)

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-172 OF THE URBANA LOCAL TRAFFIC CODE ESTABLISHING CURB LOADING ZONES ON CERTAIN STREETS

(Clark Street)

WHEREAS, the City of Urbana ("Urbana") is an Illinois Municipal Corporation pursuant to the Illinois Constitution of 1970 and the Statutes of the State of Illinois;

WHEREAS, the City of Urbana has adopted a local traffic code which is set forth in its ordinances as Section 23-1 *et seq.*; and

WHEREAS, the City of Urbana, pursuant to the aforesaid traffic code, has the authority to regulate locations marked as curb loading zones on its streets and in its parking lots; and

WHEREAS, the City of Urbana regulates loading zones on streets to provide public safety and access;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-172, entitled "Standing in Curb Loading Zones" of Article XIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street which shall be established as a loading zone on the designated days or times:


Street Direction Days Hours Duration
Clark Street from Westbound Everyday 24 15 minutes
337 feet east of the
centerline of Lincoln
Avenue to 416 feet east
of the centerline of
Lincoln Avenue

Section 2. Those sections, paragraphs, and provisions of the Urbana City Code that are not expressly amended or repealed by this Ordinance are hereby re-enacted, and it is expressly declared to be the intention of this Ordinance not to repeal or amend any portions of the Urbana City Code other than those expressly set forth as amended or repealed in this Ordinance. The invalidity of any section or provision of this Ordinance hereby passed and approved shall not invalidate other sections or provisions thereof. Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance. Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
