SUBJECT: REVISED RESOLUTION APPROVING THE ENGAGEMENT OF

LAUTERBACH & AMEN, LLP FOR INDEPENDENT FINANCIAL

AUDITING SERVICES

At the February 21, 2022 City Council Committee of the Whole meeting, the Urbana City Council requested changes to the resolution approving the engagement of Lauterbach & Amen, LLP (L&A) for independent financial auditing services. The proposed resolution authorized the Mayor to engage the services of L&A as the independent auditor for the City for the fiscal years ending June 30, 2022, 2023, 2024, 2025 and 2026, and to approve applicable extensions for three additional years, pursuant to the Request for Proposals (RFP) issued for such services and the proposal submitted by L&A. City Council requested a change to remove the authorization to engage the services of L&A beyond the initial five-year term. Therefore, based on City Council discussion and recommendation, the authorization for the Mayor to approve the optional three-year extension, has been removed from this resolution. As the five-year term comes to a close, the need for an extension will be evaluated as the City will be in a better position to assess those needs. Therefore, the Finance Department will present a resolution for City Council's approval of an extension with L&A or they will initiate a competitive RFP process, at that time.

City Council also requested additional information regarding the current relationship with L&A to ensure that the audit engagement wouldn't impair their independence. Both pension fund boards (police and fire) currently utilize L&A for actuarial work and for occasional assistance with complex pension calculations. As the memo states, this should not present a conflict, since there is no overlap between the staff on those engagements. Both boards act independently of the City to engage professional services. The City has not engaged L&A for accounting work in the past.

Additionally, the independence standards for single audits allow L&A's actuarial team to provide all consulting work and funding recommendations with the Fire and Police pension Funds since they would work with an independent actuarial firm (MWM Consulting) to provide their opinion on the accounting disclosures required by the Governmental Accounting Standards Board Statement Number 68 (GASB 68). This arrangement meets the independence standards for organizations subject to single audits. The City of Urbana is subject to single audit requirements and the Uniform Guidance rules due to the amount of federal funds expended. Single audits are intended to provide a cost-effective audit for non-Federal entities in that one audit is conducted in lieu of multiple audits of individual programs. L&A will communicate directly with the independent firm once their actuarial team has gone through their calculations.
