a. Ordinance No. 2022-05-019: An Ordinance Repealing Ordinance No. 2020-12-069 Pertaining to Ratification of Emergency Order 20-12

Presented by Mayor Marlin. Item repeals previous emergency order passed during 2020 in response to the COVID-19 pandemic that granted financial assistance in paying sanitary sewer utility fees alongside City of Champaign. This emergency order is no longer needed because another funding source has become available to assist residents with their fees. Questions and discussion ensued.
