SUBJECT: A RESOLUTION APPROVING AND AUTHORIZING THE ADOPTION

OF THE CITY OF URBANA EXTENSION OF THE HOUSING REHABILITATION MANUAL PROGRAM YEARS 2005-2006

Description

On the agenda for the June 28, 2005 meeting of the Community Development Commission is a version of the Housing Rehabilitation Manual with minor revisions, presented for approval for use in the 2005-2006 Program Year.

Issues

The issue is whether the Community Development Commission should recommend approval of the manual to the Urbana City Council.

Background

The Grants Management Division of the City of Urbana engages in a number of housing repair and rehabilitation programs. The guidelines for each of these programs are detailed in the Housing Rehabilitation Manual. The last version of this manual was designed for implementation concurrent with the 2000-2004 Consolidated Plan. As a new Consolidated Plan has been developed for 2005-2009, the time has come for this manual to be updated.

At the April 26, 2005 meeting of the Community Development Commission, Randy Burgett, the Housing Rehab Specialist, presented an overview of the five programs described in the manual. He went on to outline some of the program changes that have been considered by GM staff. A discussion between staff and commissioners followed.

A number of the changes discussed at the April meeting are new programs, or significant enough changes to existing programs, that they require further investigation in order for staff to produce program descriptions, policies and procedures that will ensure success. However, the current manual is only set to be in place through June 30, 2005. As such, staff has elected to present the Commission with a moderately revised version of the manual to allow for the programs to continue

without interruption. In the coming months, a more extensively revised manual will be presented that, once approved, can replace the version currently under consideration.

Options

- 1. Recommend the manual as written to City Council
- 2. Recommend the manual with amendments to City Council.
- 3. Do not recommend the manual to City Council.

Fiscal Impacts

There would be no fiscal impact to the city budget. The Housing Rehabilitation Manual is simply a programmatic guide. Funding allocations for each program have been established by the 2005-2006 Annual Action Plan.

Recommendations

Staff recommends that the Community Development Commission forward a favorable recommendation to City Council for this document.
