Pension Fund - Buy Back of Service Time:

Kim Cessna: ISP contacted R. Eldridge regarding buying back service time for SERS. A check was issued to SERS, in the amount of \$10,098.89.

David Roesch: D. Roesch is interested in buying back 45 months of his IMRF time. A check was sent to S. Royal in the amount of \$12,954 for his Urbana Pension. R. Eldridge will take care of the transfer letter to IMRF regarding the amount owed.

Dan Morgan: The transfer of time from Article 3 to Article 3 is okay w/ the Department of Insurance, since they previously advised it was ok to R. Eldridge.

Contract w/ Officer & Pension Fund: S. Royal stated he received a call from CPD regarding the DOI approving of the Pension Fund entering into a contract w/ an active officer to buy back their service time. The DOI told CPD they could not do enter into a contract w/ and officer.

R. Eldridge stated he talked to Mike Langenfield with the DOI earlier and Langenfield stated it was OK for the Board to have a contract w/ an Officer regarding a payment plan for pension buyback. Lagenfield has since told Ron the DOI has thought about it, and they don't know if that's still the DOI's position, but they would honor what he Initially told him, that a Contract is OK. The Fund will receive 6% interest for monies loaned.

Passing – Helen Waller: The Fund has been advised H. Waller, a widower of the Fund, was 80 years old and passed away on January 15, 2008. Her death certificate has been received and an adjusted final check will be sent to her estate.
