## AN ORDINANCE LEVYING TAXES FOR ALL TOWN PURPOSES FOR THE TOWN OF CUNNINGHAM, CHAMPAIGN COUNTY, ILLINOIS, FOR THE TAX YEAR 2014, COLLECTIBLE IN 2015

An ordinance levying taxes for all town purposes for the Town of Cunningham, Champaign County, Illinois, for the tax year 2014, collectible in 2015.

BE IT ORDAINED by the Township Board of the Town of Cunningham, Champaign County, Illinois, as follows:

SECTION 1: That, pursuant to the authority granted by the Township

Code, Illinois Compiled Statutes, Chapter 60, Article 235, and such other

statutes as are applicable, the sum one million, three hundred three

thousand, three hundred fifty-eight dollars and zero cents (\$1,303,358.00) is

hereby levied upon all property subject to taxation within the Township as

that property is assessed and equalized, in order to meet and defray all the

necessary expenses and liabilities of the Township as required by statute or

voted by the people in accordance with the law, for such purposes as:
