

**ORDINANCE NO. T-2013-07-001**

**Transfer of Appropriation Ordinance,  
Cunningham Township Budget FY 2012-2013  
(June 2013)**

Whereas there was adopted on July 02, 2012, by the Township Board of the Town of Cunningham in the County of Champaign, State of Illinois, a budget and appropriation ordinance for the fiscal year beginning July 01, 2012, and ending June 30, 2013.

And whereas it now appears that certain adjustments between appropriation items in the Town Fund and General Assistance Fund in said ordinance are desirable and necessary;

And whereas Section 3 of the Illinois Municipal Budget Law (50 ILCS, 330/3), approved July 12, 1937, as amended, authorizes transfers between the various items within any fund in such appropriation ordinance not exceeding in the aggregate 10 percent of the total amount appropriated in such fund by such ordinance.

Now therefore, be it ordained by the Township Board of the Town of Cunningham, in the County of Champaign, State of Illinois, as follows:

**TOWN FUND ADMINISTRATION**

1. Transferred **\$340.00** to **Town Fund Administration Supervisor's Salary (\$55,932.00)** from **Town Fund Administration Separation Pay (\$1,000.00)**, making the adjusted appropriation for **Town Fund Administration Supervisor's Salary (\$56,272.00)** and the adjusted appropriation for **Town Fund Administration Separation Pay (\$660.00)**.
2. Transferred **\$109.00** to **Town Fund Administration Board's Salary (\$4,000.00)** from **Town Fund Administration Separation Pay (\$660.00)**, making the adjusted appropriation for **Town Fund Administration Board's Salary (\$4,109.00)** and the adjusted appropriation for **Town Fund Administration Separation Pay (\$551.00)**.
3. Transferred **\$274.00** to **Town Fund Administration Health Insurance (\$20,000.00)** from **Town Fund Administration Separation Pay (\$551.00)**, making the adjusted appropriation for **Town Fund Administration Health Insurance (\$20,274.00)** and the adjusted appropriation for **Town Fund Administration Separation Pay (\$277.00)**.
4. Transferred **\$832.00** to **Town Fund Administration Salaries - Other (\$51,000.00)** from **Town Fund Administration Legal (\$50,000.00)**, making the adjusted appropriation for **Town Fund Administration Salaries - Other (\$51,832.00)** and the adjusted appropriation for **Town Fund Administration Legal (\$49,168.00)**

**TOWN FUND ASSESSOR**

5. Transferred **\$2,663.00** to **Town Fund Assessor Health Insurance (\$31,300.00)** from **Town**

**Fund Assessor Salaries - Other (\$125,000.00)**, making the adjusted appropriation for **Town Fund Assessor Health Insurance (\$33,963.00)** and the adjusted appropriation for **Town Fund Assessor Salaries - Other (\$122,337.00)**.

**GENERAL ASSISTANCE**

6. Transferred **\$180.00** to **General Assistance Health Insurance (\$15,600.00)** from **General Assistance Separation Pay (\$1,000.00)**, making the adjusted appropriation for **General Assistance Health Insurance (\$15,780.00)** and the adjusted appropriation for **General Assistance Separation Pay (\$820.00)**.
  
7. Transferred **\$60.00** to **General Assistance Work/Training (\$9,500.00)** from **General Assistance Medical Care (\$220,000.00)**, making the adjusted appropriation for **General Assistance Work/Training (\$9,560.00)** and the adjusted appropriation for **General Assistance Medical Care (\$219,940.00)**.
  
8. Transferred **\$961.00** to **General Assistance Personal Allowance (\$420,000.00)** from **General Assistance Medical Care (\$219,940.00)**, making the adjusted appropriation for **General Assistance Personal Allowance (\$420,961.00)** and the adjusted appropriation for **General Assistance Medical Care (\$218,979.00)**.

These transfers shall be in full force and effect from and after this date.
