AN ORDINANCE LEVYING TAXES FOR ALL TOWN PURPOSES FOR THE TOWN OF CUNNINGHAM, CHAMPAIGN COUNTY, ILLINOIS, FOR THE TAX YEAR 2019, COLLECTIBLE IN 2020

BE IT ORDAINED by the Township Board of the Town of Cunningham, Champaign County, Illinois, as follows:

SECTION 1: That, pursuant to the authority granted by the Township Code, Illinois Compiled Statutes, Chapter 60, Article 235, and such other statutes as are applicable, the sum one million, three hundred eighty seven thousand six hundred thirty one and no cents (\$1,471,734) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund, \$ 761,000.00 General Assistance Fund \$ 626,631.00

for the tax year 2019, collectible in 2020.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

35 ILCS 200/18-90: Along with their tax levy, EVERY taxing district is required to file a certification by the presiding officer of the district certifying compliance with or inapplicability of the provisions of Truth in Taxation law.

LOCAL

The City of Urbana and Cunningham Township are asking for increases of 31.1% and 24.3%, respectively, in the property tax levy. This is based on the possibility that hospital properties could be considered taxable for the 2019 tax levy.

The City intends to reduce the tax levy so that the current tax rates remain in place. For the owner of a \$150,000 owner-occupied home, that would mean a City property tax bill of \$594, the same as in 2018, assuming the value of the property does not change. Urbana homeowners should not see any increase in their property tax bill for City taxes, unless the assessment on their property has increased.

Cunningham Township will limit its tax extension to that which is allowable under tax caps.

Please note that the City share of the total property tax bill is approximately 13% and the Township's share is about 2%.
