ORDINANCE NO. T-2021-12-003

AN ORDINANCE LEVYING TAXES FOR ALL TOWN PURPOSES FOR THE TOWN OF CUNNINGHAM, CHAMPAIGN COUNTY, ILLINOIS, FOR THE TAX YEAR 2021, COLLECTIBLE IN 2022

BE IT ORDAINED by the Township Board of the Town of Cunningham, Champaign County, Illinois, as follows:

SECTION 1: That, pursuant to the authority granted by the Township Code, Illinois Compiled Statutes, Chapter 60, Article 235, and such other statutes as are applicable, the sum two million, three hundred thousand and no cents (\$2,300,000) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund, \$918,000
General Assistance Fund \$1,382,000

for the tax year 2021, collectible in 2022.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid, or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.

Notice of Proposed Property Tax Increase for the Town of Cunningham, Urbana, Illinois.

I. A public hearing to approve a proposed property tax increase for the Town of Cunningham for 2021 will be held on Monday December 13th, 2021 at 6:30 PM virtually via zoom. II. The corporate and special purpose property taxes extended or abated for 2020 were \$1,825,178.00. The proposed corporate property taxes to be levied for 2021 are \$2,300,000.00. This represents a 26% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2020 were \$0. The estimated property taxes to be levied for debt service and public building commission leases for 2021 are \$0. This represents a 0.00% increase over the previous year.

IV. The total property taxes extended or abated for 2020 were \$1,825,178.00. The estimated total property taxes to be levied for 2021 are \$2,300,000.00. This represents a 26% increase over the previous year.
