ORDINANCE 11 OF FY 1917 (1617-11)

AN ORDINANCE FOR THE VACATION OF AN ALLEY

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That the alley running east and west from Lincoln

Avenue and lying between Lots 1, 2, 3, 4, and 5 on the North and Lots
6, 7, 4, 9, and 10 on the South of a Subdivision of Lot 20 of M.W.

Busey's Heirs Addition to the Gity of Urbana, be and the same is hereby vacated and the persons owning the lots adjoining on said alley are hereby entitled to the use of said alley for private purposes according to their bespective rights in said alley.

The property owners taking the use of the ground in said alley are hereby required to re-imburse the City for the amount paid for the pavement of Lincoln Avenue in front of said alley.

Adopted by the City Council this 4th day of December, A.D. 1916.
