

AN ORDINANCE TO VACATE AND RELEASE THE RIGHTS OF THE CITY TO THE USE OF AN ALLEY.

Be it Ordained by the City Council of the City of Urbana, Illinois:

SECTION 1 - That the City Council of the City of Urbana, Illinois, hereby vacates and relinquishes to the abutting lot owners the use of the alley running North and South between Lot Nine (9) on the West side thereof and Lot Ten (10) on the East side thereof Noel's Subdivision of Lot Eight (8) of J. S. Busey's Addition of Out Lots to the City of Urbana, Illinois; said alley extending from Nevada Street North along the line of and between the aforesaid lots to the South line of the alley extending East and West in the center of the block in which said Lots Nine (9) and Ten (10) are situated.

SECTION 2 - That this ordinance shall take effect and be in force from and after its passage and approval.

AN ORDINANCE TO VACATE A BERTION OF AN ALLEY

Be it ordained by the City Council of the City of Trbana, Illinois:

that so much of the alley between Birch and McCullough Streets and extending North and South from Nevada Street to the alley extending East and West between Birch and McCullough Streets and between Nevada and Oregon Streets, also described as between Lots 9 and 10, Noels Subdivision of Lot 8, J. S. Buseys Addition of Outlots to the City of Urbana, be and the same is hereby vacated by the City of Urbana.

The City of Urbana hereby releases and quit-claims to
the present owners of Lots 9 and 10 as aforesaid all of the
right, title and interest heretofore had by the City in or to
said alley herein vacated, that is to say; to the present owner
of Lot 9, Noels Subdivision of J. S. Buseys Addition of Outlots
to the City of Urbana, the west half of said vacated alley
and to the present owner of Lot 10, NoelsSubdivision of
J. S. Buseys Addition of Outlots to the City of Urbana, the east
half of said vacated alley.
