Local Liquor Control Commissioner

SECTION 3. For each regular or special meeting of the City Council attended by him, each alderman shall receive a compensation of \$ 5.00.

SECTION 4. All employees who shall have been employed continuously for a minimum of one year upon the public streets or public sewers shall receive wages at the rate of . . . . . \$160.0 per month. All other employees in the street department or working in the sewer or drainage department, who shall be employed by the City for less than one year, and all helpers of the City Electrician or working in the electrical department shall receive eighty cents per hour.

SECTION 5. Each member of the Civil Service Commission shall receive \$1.00 per year full payment of his services on the said commission.

SECTION 6. The commissioner of public works shall furnish his own automobile or truck for his use in city business. The City shall furnish the gasoline and oil for said city use and shall also furnish public liability and property damage insurance for said automobile or truck to cover the performance of the duties of said officer of said City.

SECTION 7. In addition to the compensation hereinabove fixed, the Mayor, Corporation Counsel, and City Clerk shall receive such compensation for services to the Board of Local Improvements of the City of Urbana, Illinois, as shall from time to time be determined by the Board of Local Improvements of said City, and nothing herein contained shall be construed as limiting the Board of Local Improvements in paying the said officers compensation for services rendered to said board.

SECTION 8. All ordinances or parts of ordinances in conflict herewith, are hereby repealed.
