AN ORDINANCE FOR THE ANNEXATION OF TERRITORY

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that a petition was filed with the County Clerk of Champaign County on the 13th day of September, 1946, requesting the annexation of the territory herein described to the City of Urbana, and requesting the Judge of the County Court of Champaign County to submit the question of the annexation of said territory to the corporate authorities of said City, said territory being described in said petition as follows:

The North Half (N½) of the Northwest Quarter (NW½) of the Southwest Quarter (SW½) of Section Sixteen (16), Township Nineteen (19) North, Range Nine (9) East of the 3rd Principal Meridian, in Champaign County, Illinois, except the North One Hundred Sixty Five Feet (165) thereof

And it further appearing to the City Council that a hearing was had in the County Court on said petition, and that proper notices were given according to law of said hearing by publication in the Champaign-Urbana Courier, and by posting notices in five of the most public places in said territory, and that pursuant to said hearing the Judge of said County Court entered an order directing the question of the annexation of said territory be submitted to the corporate authorities of the City of Urbana, Illinois, and

WHEREAS, the City Council of said City finds that a certified copy of the order of the County Court entered on the 9th day of October, 1946, was sent to the City Clerk of the City of Urbana, Illinois, and that said order finds that all the neccessary legal steps were taken by the petitioners for the annexation of said territory to the City of Urbana; that said order finds that the petition requesting said annexation was signed by a majority of the owners of record of land in said described territory, and also by a majority of the electors residing in such territory; that said certified copy of the order was received by the City Clerk of the City of

Trbana from the Clerk of the County Court of Champaign County on the 21 day of October, 1946, and

WHEREAS, it appears to the City Council that there were no objections filed in the County Court to the annexation of said territory to the City of Urbana:

IT IS. THEREFORE, the opinion of more than two-thirds of the duly elected aldermen of said City that it would be to the best interest of the territory described in said petition, and for the best interest of the landowners and electors of said territory, and for the best interest of the entire City of Urbana that said territory be annexed to and become a part of the City of Urbana.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That the territory described as: -

The North Half (Na) of the Northwest Quarter (NW1) of the Southwest Quarter (SW1) of Section Sixteen (16), Township Nineteen (19) North, Range Nine (9) East of the 3rd Principal Meridian, in Champaign County, Illinois, except the North One Hundred Sixty Five Feet (165) thereof

be and the same is hereby annexed to and shall become a part of the City of Urbana, Illinois, and that the corporate limits of said City be and the same shall be changed so as to include said territory within the corporate limits of said City.

Section 2. This ordinance shall be in full force and effect on the expiration of thirty days from the date of this ordinance unless a referendum thereon shall be subsequently ordered by said City Council or unless a petition for such referendum shall be filed with the City Clerk of said City. In case of such a referendum, this ordinance shall be of full force and effect if a majority of the electors voting upon the question favor the annexation of such territory to the City of Urbana. If a majority of the electors voting upon the question vote against such annexation, then this ordinance shall become null and void.
