

AN ORDINANCE PROVIDING FOR THE SUBMISSION  
OF THE QUESTION OF ADOPTION OF ARTICLE  
53.1 OF CHAPTER 24 OF THE REVISED STATUTES  
PERMITTING CITIES AND VILLAGES TO LEVY A  
TAX FOR POLICE PROTECTION PURPOSES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA,  
ILLINOIS:

Section 1. That the question of the adoption of said Article 53.1 of Chapter 24 of the Revised Statutes of the State of Illinois, permitting cities and villages containing less than 500,000 inhabitants to levy a tax of not to exceed .075 per cent for Police Protection Purposes within the City of Urbana, Illinois, in addition to the amount authorized to be levied for general corporate purposes, be and the same is hereby submitted to the electors of said City of Urbana.

Section 2. That a special election shall be held, and is hereby ordered and directed to be held in and for the City of Urbana, Illinois, on the 27th day of March A. D. 1948, at the polling places below described for the purpose of submitting to the electors of the said City of Urbana the question of the adoption of said Article 53.1 of Chapter 24 of the Revised Statutes of the State of Illinois.

Section 3. That for the purpose of said election, the City of Urbana shall be divided into four special election districts and the polling places therefor as follows:

DISTRICT NO. 1 - All that part of the City of Urbana lying north of the center line of Green Street and extending north to the city limits and lying west of the center line of Race Street and extending west to the city limits. The polling place for said district shall be in the basement of the Lincoln School Building, the northwest corner of Lincoln Avenue and Main Street in said City.

DISTRICT NO. 2 - All that part of Urbana lying south of the center line of Green Street and extending south to the city limits and lying west of the center line of Race Street and extending west to the city limits. Polling place for said district shall be on the first floor of the Leal School Building located at 302 West Oregon Street in said City.

DISTRICT NO. 3 - All that part of the City of Urbana lying south of the center line of Green Street and extending south to the city limits and lying east of the center line of Race Street and extending east to the city limits. The polling place for said district shall be the Foursquare Gospel Church at the northeast corner of Broadway and Oregon Street.

DISTRICT NO. 4 - All that part of the City of Urbana lying north of the center line of Green Street and extending north to the city limits and lying east of the center line of Race Street and extending east to the city limits. The polling place for said district shall be the Police Magistrate's Court room in the City Building at the northwest corner of Broadway and Elm Street in said City.

The polls shall be opened at the hour of six o'clock A. M. and shall be kept open until the hour of five o'clock P. M. when the polls shall be closed.

Section 4. The following named, qualified electors of the City of Urbana shall be and they are hereby appointed Judges and Clerks respectively for the aforesaid election as follows:


Said City Clerk is further directed to give notice of said election by publication in the Champaign-Urbana Courier, a secular newspaper published and having general circulation in said City not less than fifteen days prior to the date set for said election.

Section 5. This ordinance shall become in full force and effect only if the majority of the votes cast on the question of the adoption of Article 53.1 of Chapter 24 of the Revised Statutes of the State of Illinois, are in favor of its adoption. Should the majority of the votes cast on said question not favor the adoption of said Article, then this ordinance shall be void and of no effect.
