AN ORDINANCE CALLING A SPECIAL ELECTION TO BE HELD IN AND FOR THE CITY OF URBANA, CHAMPAIGN COUNTY, ILLINOIS, FOR THE PURPOSE OF SUBMITTING TO THE VOTERS OF SAID CITY FOR THEIR APPROVAL OR REJECTION AN ORDINANCE ENTITLED " AN ORDINANCE PROVIDING FOR THE ISSUANCE OF SIXTY FIVE THOUSAND (\$65,000.00) DOLLARS, SPRINGFIELD AVENUE EXTENS PUBLIC IMPROVEMENT BONDS FOR THE PURPOSE OF EX-SPRINGFIELD AVENUE EXTENSION TENDING SPRINGFIELD AVENUE FROM COLER AVENUE TO McCULLOUGH AVENUE, OF THE WIDTH OF SIXTY FEET, AND THE ACQUISITION OF THE NECESSARY REAL ESTATE THEREFOR, AND THE CONSTRUCTION THEREON OF A CON-CRETE CEMENT PAVEMENT THIRTY SEVEN FEET IN WIDTH INCLUDING CONCRETE CURB AND GUTTER, AND INCLUDING EXCAVATING, DRAINING, AND ILLUMINATING SAID EX-TENSION, AND ALSO CONSTRUCTION OF A CONCRETE CEMENT SIDEWALK ADJACENT TO THE PROPERTY LINE ALONG EACH SIDE OF EXTENDED STREET; AND THE CONSTRUCTION OF A CULVERT OVER THE BONEYARD BRANCH, AND THE WIDENING OF THE PRESENT PAVEMENT ON SPRINGFIELD AVENUE FROM BUSEY AVENUE TO COLER AVENUE TO THE WIDTH OF THIRTY SEVEN FEET, AND PROVIDING FOR THE LEVY AND COLLECTION OF A DIRECT ANNUAL TAX SUFFICIENT TO PAY THE SAME."

WHEREAS, a certain ordinance designated as "An Ordinance Providing For The Issuance of Sixty Five Thousand (\$65,000.00) Dollars Springfield Avenue Extension Public Improvement Bonds For The Purpose Of Extending Springfield Avenue From Coler Avenue to McCullough Avenue, Of the Width Of Sixty Feet, And The Acquisition Of The Necessary Real Estate Therefor, And The Construction Thereon Of A Concrete Cement Pavement Thirty Seven Feet In Width Including Concrete Curb and Gutter, And Including Excavating, Draining, and Illuminating Said Extension, And Also Construction of a Concrete Cement Sidewalk Adjacent To The Property Line Along Each Side of Extended Street; And The Construction Of A Culvert Over The Boneyard Branch, And The Widening Of The Present Pavement On Springfield Avenue From Busey Avenue To Coler Avenue To the Width Of Thirty Seven Feet, And Providing For The Levy And Collection Of A Direct Annual Tax Sufficient To Pay The Same, " was duly passed by the City Council on the 15thday of March, 1948, and signed by the Mayor on the 15th day of March, 1948, and

WHEREAS, before said ordinance can be operative, effective or valid, it is necessary that it be submitted, in accordance with law, to the voters of the City of Urbana at an election duly called and held and approved by the majority of the voters voting upon the question:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That a special election shall be held and is hereby ordered and directed to be held in and for the City of Urbana, Champaign County, Illinois, on the <u>Toth</u> day of April A. D. 1948, at the polling places below described for the purpose of submitting to the voters of said City for approval or rejection an ordinance for the City of Urbana entitled:

"An Ordinance providing for the issuance of Sixty Five Thousand (\$65,000.00) Dollars Springfield Avenue Extension Public Improvement Bonds for the purpose of extending Springfield Avenue from Coler Avenue to McCullough Avenue, of the width of sixty feet, and the acquisition of the necessary real estate therefor, and the construction thereon of a concrete cement pavement thirty seven feet in width including concrete curb and gutter, and including excavating, draining, and illuminating said extension, and also construction of a concrete cement sidewalk adjacent to the property line along each side of extended street; and the construction of a culvert over the Boneyard Branch, and the widening of the present pavement on Springfield Avenue from Busey Avenue to Coler Avenue to the width of thirty seven feet, providing for the levy and collection of a direct annual tax sufficient to pay the same."

passed by the City Council of said City and signed by the Mayor of said City on the 15th day of March A. D. 1948.

Section 2. That for the purpose of said election, the City of Urbana shall be divided into four special election districts and polling places therefor as follows:

DISTRICT NO. 1. - All that part of the City of Urbana lying north of the center line of Green Street and extending north to the city limits and lying west of the center line of Race Street and extending west to the city limits. The polling place for said district shall be in the basement of the Lincoln School Building, the northwest corner of Lincoln Avenue and Main Street in said City.

DISTRICT NO. 2. - All that part of Urbana lying south of the center line of Green Street and extending south to the city limits and lying west of the center line of Race Street and extending west to the city limits. Polling place for said district shall be on the first floor of the Leal School Building located at 302 West Oregon Street in said City.

<u>DISTRICT NO. 3.-</u> All that part of the City of Urbana lying south of the center line of Green Street and extending south to the city limits and lying east of the center line of Race Street and extending east to the city limits. The

POLLING PLACE FOR SAID DISTRICT SHALL BE Foursquare Gospel Church, northeast corner of Broadway and Oregon Streets.

DISTRICT NO. 4. - All that part of the City of Urbana lying north of the center line of Green Street and extending north to the city limits and lying east of the center line of Race Street and extending east to the city limits. The polling place for said district shall be the Police Magistrate's Court room in the City Building at the northwest corner of Broadway and Elm Street in said City.

The polls shall be opened at the hour of six o'clock

A. M., and shall be kept open until the hour of five o'clock

P. M., when the polls shall be closed.

The polling place for said district shall be in the basement of the Lincoln School Building, the northwest corner of Lincoln Avenue and Main Street in said City.

<u>DISTRICT NO. 2.</u> All that part of Urbana lying south of the center line of Green Street and extending south to the city limits and lying west of the center line of Race Street and extending west to the city limits. Polling place for said district shall be on the first gloor of the Leal School Building located at 302 West Oregon Street in said City.

DISTRICT NO. 3. All that part of the City of Urbana lying south of the center line of Green Street and extending south to the city limits and lying east of the center line of Race Street and extending east to the city limits. The polling place for said district shall be the Foursquare Gospel Church, northeast corner of Broadway and Oregon Streets.

District NO. 4. All that part of the City of Urbana lying north of the center line of Green Street and extending north to the city limits and lying east of the center line of Race Street and extending east to the city limits. The polling place for said district shall be the Police Magistrate's Court room in the City Building at the northwest corner of Braodway and Elm Street in said City.
