AN ORDINANCE FIXING COMPENSATION OF OFFICERS AND EMPLOYEES OF THE CITY OF URBANA, ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS: -SECTION 1. That beginning May 1, 1948, the monthly salaries of the following named officers and employees of the City of Urbana, Illinois, shall be as follows: Mayor \$ 140.00 City Clerk and Special Collector . . 190.00 Assistant City Clerk (Including keeping motor fuel tax records). . . 147.50 City Treasurer . . 30.00 City Attorney 125.00 Commissioner of Public Works . . . 265.00 City Electrician 265.00 Assistant City Electrician . . 197.50 Police Magistrate 110.00 City Marshall (Chief of Police) including cost of furnished automobile) 265.00 Police Patrolman (Serving on Probation) 200.00 Police Patrolman (Serving under temporary appointment) 210.00 Police Patrolman (Regular) not to exceed \$75.00 for uniforms additional: 230.00 Custodian of Dump Grounds 65.00 Police Sergeant . . . 237.50 Fire Marshall (Including cost of furnished automobile) 265.00 Assistant Fire Marshall 245.00 Captian of Firemen 240.00 Lieutenant of Firemen 235.00 Firemen (Regular) 230.00 Firemen (On probation) 200.00 Firemen (Temporary) 210.00 Janitor (Custodian) of City Bldg. :Rest Room fund . . 117.50 :General fund . . . 40.00 Janitor of Municipal Hall & Recreation Center . . . 160.00 Matron of restroom (Police Matron) . . 70.00 Assistant Matron of Rest Room Foreman in Street Department 230.00 Local Liquor Control Commissioner 25.00

SECTION 4. All employees who shall have been employed continuously for a minimum of one year upon the public streets or public sewers shall receive wages at the rate of \$197.50 per month. All other employees in the street department or working in the sewer or drainage department, who shall be employed by the City for less than one year, and all helpers of the City Electrician or working in the electrical department shall receive One Dollar cents per hour.

SECTION 5. Each member of the Civil Service Commission shall receive Ten Dollars per year full payment of his services on the said Commission.

SECTION 6. The Commissioner of Public Works shall furnish his own automobile or truck for his use in city business. The City shall furnish the gasoline and oil for said city use and shall also furnish public liability and property damage insurance for said automobile or truck to cover the performance of the duties of said officer of said City.

SECTION 7. In addition to the compensation hereinabove fixed, the Mayor, Corporation Counsel, and City Clerk shall receive such compensation for services to the Board of Local Improvements of the City of Urbana, Illinois, as shall from time to time be determined by the Board of Local Improvements of said City, and nothing herein contained shall be construed as limiting the Board of Local Improvements in paying the said officers compensation for services rendered to said Board.

SECTION 8. All ordinances or parts of ordinances in conflict herewith, are hereby repealed.
