AN ORDINANCE
PROVIDING FOR THE CALLING OF A SPECIAL
ELECTION TO FILL THE VACANCY IN
THE OFFICE OF MAYOR

WHEREAS, a vacancy has occurred in the Office of the Mayor of the City of Urbana, Illinois, and there remains an unexpired term of said Mayor of more than one year:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That a special election be and is hereby called for the purpose of filling the vacancy in the office of mayor in the City of Urbana caused by the death of Joe R. Somers who was duly elected mayor at the last regular city election held in and for said City of Urbana, Illinois, and who qualified and took office as such mayor on the 1st day of May, 1949, and died on the 19th day of July, 1949, leaving an unexpired term of more than three and one-half years.

Section 2. That in order to choose candidates for the office of mayor to fill said unexpired term of the said Joe R. Somers, that a special primary election be held within said city on the 11th day of October, 1949, and that the city clerk of said city publish the required notice of said primary election as provided by statute in order to enable any prospective candidate for the office of said mayor to file his or her petition under the label of the political party of his choice; that said city clerk otherwise comply with the requirements of the statute in such case made and provided for the conduct of said primary election ~~with~~ notification to the successful candidates in the respective political parties appearing in said primary election.

Section 3. That the special election for choice of mayor for said city from the successful nominees at said primary election be and the same is hereby set for the 13th day of December, 1949, and the city clerk of said city is hereby directed to give the proper notices of said election as provided by statute, and otherwise comply with the said statute in the printing of ballots

and other proceedings connected with said election.

Section 4. That both said special primary and said special election be held in each of the seven wards, being all the wards in said city, and that the City Council of said city hereby establish the polling place in each ward as follows - said polling places shall be for both the special primary and special election.



Section 5. That the City Council of said City appoint three judges and three clerks out of each of the respective wards to act as judges and clerks of both the special primary and special election, and that said judges and clerks be selected and notified


in ample time prior to said special primary and special election as provided by law; that the City Council as provided by statute canvass the returns of both special primary and special election and announce the successful candidate and declare the successful candidate for mayor as determined by the electors in said special election.
