AN ORDINANCE ANNEXING TERRITORY SOUTH OF FLORIDA AVENUE AND WEST OF RACE STREET TO THE CITY OF URBANA, ILLINOIS.

WHEREAS, the University of Illinois by Petition caused on the 17th day of October, 1945, the County Court of Champaign County, Illinois, to enter an order to submit the question of annexation to the corporate authority of the City of Urbana, Illinois, the territory described below, and

WHEREAS, it appears that this territory is contiguous to the municipality of the City of Urbana, the same adjoining Florida Avenue on the south and Race Street extended on the west,

NOW, THEREFORE, BE IT ORDAINED THAT the following territory be annexed to the City of Urbana, p rovided the proper maps and plans be submitted to the Planning Commission of the City of Urbana and approved by said Commission.

1. That the following territory be annexed to the City of Urbana, Illinois:

The East (E) Eight Hundred and Forty-Five (845) feet of the North (N) One Thousand and Five (1005) feet of the Northwest Quarter (NW1) of Section Twenty (20), Township Nineteen North (T19N), Range Nine East (R9E) of the Third Principal Meridian (3rd PM) in the County of Champaign and State of Illinois, said territory being also known and described as follows:

Beginning at the Northeast (NE) corner of said Northwest Quarter (NW½) of Section Twenty (20) which is also the intersection of Florida Avenue and Race Street, thence westerly along the North (N) line of said Northwest Quarter (NW½) of Section Twenty (20), for a distance of Eight Hundred and Forty-Five (845) feet; thence southerly along a line which is Eight Hundred and Forty-Five (645) feet distant from and parallel to the East (E) line of the said Northwest Quarter (NW½) of Section Twenty (20) a distance of One Thousand and Five feet (1005); thence easterly along a line which is One Thousand and Five (1005) feet distant from and parallel to the North Line of said Northwest Quarter (NW½) of Section Twenty (20), a distance of Eight Hundred and Forty-five (845) feet to the East (E) line of said Northwest Quarter (NW½) of Section Twenty (20); thence northerly along the East (E) line of said Northwest Quarter (NW½) of Section Twenty (20) to the place of beginning in Township Nineteen North (T19N), Range Nine East (R9E) of the Third P rincipal Meridian (3rd PM) in the County of Champaign and State of Illinois.

2. That the maps and plans of this territory as it presently exists be submitted to the City Planning Commission for approval, and when approved made of record.

This annexation shall be effective as of the date the maps and plans are recorded following their approval by the Planning Commission.
