

AN ORDINANCE VARYING THE PROVISION OF SECTION 9 OF THE ZONING ORDINANCE OF THE CITY OF URBANA, ILLINOIS, IN A PARTICULAR CASE

WHEREAS, MRS. BARNEY HESSLER, owner of the premises described as

West 85 feet of Lot 18 and South 13.3 feet of West 85 feet of Lot 17, all in Campbell and Kelly's Addition to Urbana, Illinois,

otherwise known as 506 South Lincoln Avenue, Urbana, Illinois, has petitioned the Commissioner of Public Works for a permit to construct a one story dwelling house on the north side of said premises, said building to face on Lincoln Avenue, and

WHEREAS, because of the lot area regulations of the Zoning Ordinance of the City of Urbana as set forth in Section 9 thereof, the erection of another family dwelling on said premises is not permitted, because of the lack of sufficient lot area, and

WHEREAS, the Commissioner of Public Works denied the petition, and an appeal has been taken by the said MRS. BARNEY HESSLER from the decision of the Commissioner of Public Works, and

WHEREAS, a public hearing has been duly held pursuant to a notice published in the Champaign-Urbana Courier, and

WHEREAS, it appears to the City Council that said public hearing was duly held on the 12th day of May A. D. 1949, pursuant to said notice, and that the Board of Appeals of said City has presented a resolution signed by four members of said Board stating that no property owner appeared before said Board to object to the varying of the Zoning Ordinance to permit the construction of said dwelling on the north side of said premises, and accordingly recommend to the City Council that Section 9 of the Zoning Ordinance

be amended in this particular case to permit the construction of said building, and the varying of said Section 9 of the Zoning Ordinance in this particular case to permit such construction, and

WHEREAS, it appears to the City Council that all the requirements of the Zoning Ordinance of said City have been complied with, and that said Section 9 of the Zoning Ordinance should be amended in this particular case to permit the construction of said building; that there will be unnecessary hardships in the way of carrying out the strict letter of the Zoning Ordinance in this particular case:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:


Section I. That the provisions of Section 9 of the Zoning Ordinance of the City of Urbana, Illinois, relating to the application of lot area regulations be and the same are hereby varied in this particular case to permit the construction of a one story dwelling house on the north side of the premises described as the West 85 feet of Lot 18 and the South 13.3 feet of the West 85 feet of Lot 17, all in Campbell and Kelly's Addition to Urbana, otherwise known as 506 South Lincoln Avenue, Urbana, Illinois, said building to face on Lincoln Avenue, making two family dwelling houses on said premises.
