

ORDINANCE VACATING PART OF AN ALLEY

WHEREAS: The owner of the Webber School grounds in Urbana, Illinois and Lots Nine (9), Ten (10) and Thirteen (13) of Williams Harvey's Addition to Urbana, Illinois have requested the City of Urbana, Illinois to vacate that part of an alley lying on the West side of Lots Six (6), Nine (9), Ten (10) and Thirteen (13) of Williams Harvey's Addition to Urbana, Illinois, between said lots and the Webber School grounds in Urbana, Illinois, and

WHEREAS: The owners of the part of Lot Six (6) adjoining the said part of an alley have agreed to the closing of said part of an alley, and

WHEREAS: It appears to the City Council of said City that the public interest will be subserved by the closing of said part of an alley as aforesaid:

THEREFORE: Be it ordained by the City Council of the City of Urbana:

1. That the City Council of Urbana, Illinois hereby vacates and releases to the owners of the abutting property, all the right, title and interest of the City to that portion of an alley lying on the West side of Lots Six (6), Nine (9), Ten (10) and Thirteen (13) of Williams Harvey's Addition to Urbana, Illinois, between said lots and the Webber School grounds in Urbana, Illinois.

2. This ordinance shall take effect and be in force from and after its passage and approval.

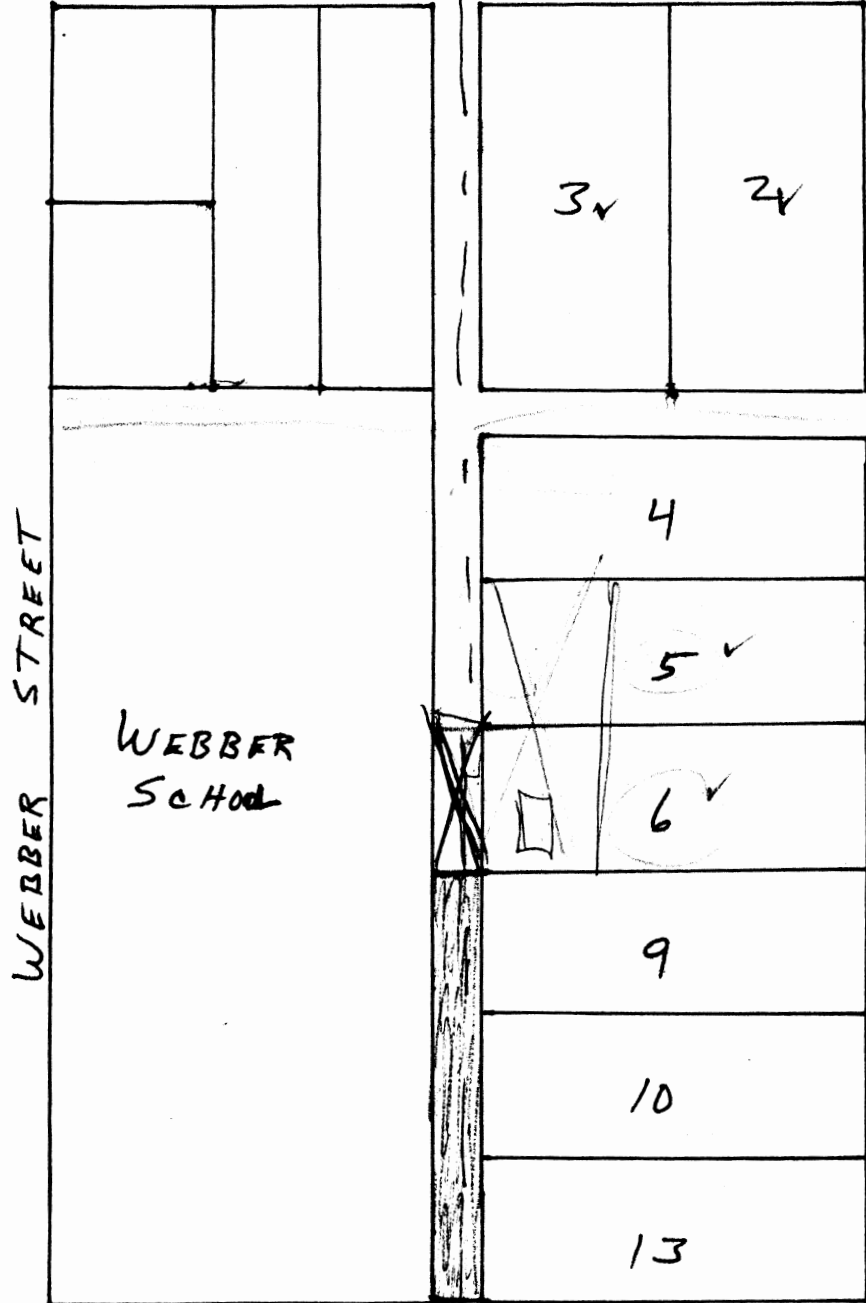

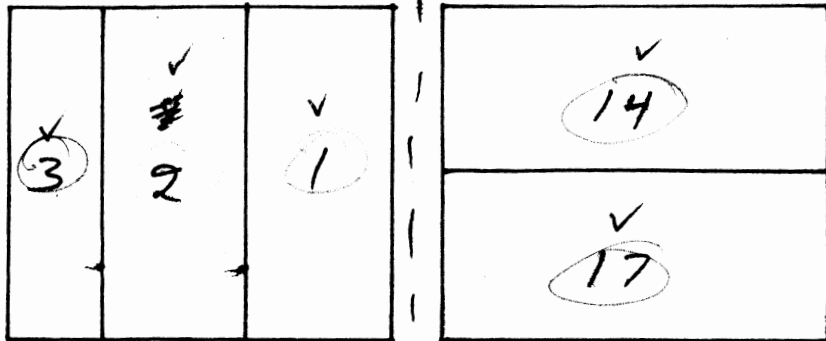
WEBBER STREET


PETITION TO THE CITY COUNCIL FOR CLOSING PART OF AN ALLEY


