

AN ORDINANCE ADDING TERRITORY TO THE SIXTH AND SEVENTH
WARDS OF THE CITY OF URBANA, ILLINOIS

WHEREAS, certain real estate has recently been annexed to the City of Urbana, Illinois, and it appearing to the City Council that it is desirable to add such territories to election wards of the City of Urbana;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS.

Section 1. That the following described territory is hereby added to and made a part of the Sixth Ward of the City of Urbana, Illinois:

The South Half of the Northwest Quarter of the Southwest Quarter of Section Sixteen (16) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, in Champaign County, Illinois.

Section 2. That the boundaries of the Sixth Ward are hereby amended to read as follows and to include the following described territory to-wit:

Commencing at the center of the intersection of Race and Green Streets in the City of Urbana, Illinois, thence South along the center line of Race Street to the center line of Washington Street, thence West along the center line of Washington Street to the center line of Race Street, thence South along the center line of Race Street to the center line of Iowa Street, thence East along the center line of Iowa Street to the center line of Broadway Avenue, thence South along the center line of South Broadway Avenue, as extended through the school property, to the center line of Florida Avenue, thence East along the center line of Florida Avenue to the East line of Vine Street, thence North along the East line of Vine Street to a point One Hundred Sixty-five Feet (165) South of the Northwest corner of the Northeast Quarter of the Southeast Quarter of Section Seventeen (17) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence East to a point One Hundred Sixty-five Feet (165) South of the Northeast corner of the Northeast Quarter of the Southeast Quarter of said Section Seventeen (17), thence South to the Southwest corner of the Northwest Quarter of the Southwest Quarter of Section Sixteen (16) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence East to the East line of Cottage Grove Avenue, thence North along the East line of Cottage Grove Avenue to the South line of Oregon Street, thence East along the South line of Oregon Street to the East line of Glover Avenue, thence North along the East line of Glover Avenue to the center line of Green Street, thence West along the center line of Green Street to the point of beginning.

Section 3. That the following described territory is hereby added to and made a part of the Seventh Ward of the City of Urbana, Illinois:

Commencing at the Northeast corner of the Northwest Quarter of the Northeast Quarter of Section Twenty (20) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian in Champaign County, Illinois, thence South Five Hundred Eighty-nine and Three Tenths (589.3) Feet to the South line of First Replat of Elm Knoll Addition, thence West along the South line of First Replat of Elm Knoll Addition to the Southwest corner of lot Eighteen (18) of said addition, thence South along the East line of the Meadows to the Southeast corner of the Meadow's Subdivision, thence West along the South line of the Meadow's Subdivision to the center line of Race Street, thence South along the center line of Race Street to a point One Thousand Five (1,005) Feet South of the Northeast corner of the Northwest Quarter of Section Twenty (20) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence West Eight Hundred Forty-five (845) Feet to the Southwest corner of University Subdivision, thence North One Thousand Five (1,005) Feet to the center line of Florida Avenue, thence East along the center line of Florida Avenue to the place of beginning.


Section 4. That the boundaries of the Seventh Ward of the City of Urbana, Illinois are hereby changed and amended to include the following territory, to-wit:

Commencing at the center of the intersection of Race Street and Oregon Street in the City of Urbana, thence South along the center line of Race Street to the center line of Washington Street, thence West along the center line of Washington Street to the center line of Race Street, thence South along the center line of Race Street to the center line of Iowa Street, thence East along the center line of Iowa Street to the center line of Broadway Avenue, thence South along the center line of Broadway Avenue, as extended through the school property, to the center line of Florida Avenue, thence East along the center line of Florida Avenue to the center line of Vine Street, thence South along the center line of Vine Street to the South line of First Replat of Elm Knoll Subdivision, thence West along the South line of First Replat of Elm Knoll Subdivision to the East line of the Meadow's Subdivision, thence South along the East line of the Meadow's Subdivision to the South line of the Meadow's Subdivision, thence West along the South line of the Meadow's Subdivision to the center line of Race Street, thence South along the center line of Race Street to the South line of University Subdivision, which line is One Thousand Five (1,005) Feet South of the center of the intersection of Florida and Race Streets, thence West Eight Hundred Forty-five (845) Feet to the Southwest corner of University Subdivision, thence North One Thousand Five (1,005) Feet to the center line of Florida Avenue, thence West along the center line of Florida Avenue to the center line of Lincoln Street, thence North along the center line of Lincoln Street to the center line of Oregon Street, thence East along the center line of Oregon Street to the point of beginning.
