AN ORDINANCE AMENDING AN ORDINANCE REGULATING THE
SALE AT RETAIL OF ALCOHOLIC LIQUORS WITHIN THE CITY OF URBANA,
ILLINOIS

WHEREAS, the City Council of the City of Urbana, Illinois did, on the 2nd day of April, 1945, adopt an ordinance entitled, "An Ordinance Regulating the Sale at Retail of Alcoholic Liquors Within the City of Urbana, Illinois," which said ordinance was duly published in pamphlet form on the 30th day of April, 1945; and

Whereas, it appears to be desirable for the welfare of the people of the City of Urbana that the license fees set forth in Section 4 of said ordinance be increased.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS That Section 4 of said ordinance be and the same is hereby amended by substituting the following Section 4 for and in lieu of said Section 4 of said ordinance:

Section 4. (Classification--fees). Such licenses shall be and are hereby divided into four classes, to-wit:

(a) Class A licenses (to be known as regular retailer's license) which shall authorize the retail sale of alcoholic liquors in package form or by the drink for consumption on or off the premises where sold. The annual license fee for which shall be (except Hotels) \$1000.00. Hotels \$1200.00.

(b) Class B licenses (to be known as the beer license) which shall authorize the retail sale of beer only to be consumed on or off the premises where sold. The annual license fee for which shall be \$250.00 in the liquor zone and \$400.00 outside the liquor zone.

(c) Class C licenses (to be known as package store licenses) which shall authorize the retail sale of alcoholic liquors in original packages not to be consumed on the premises. The annual license fee for which shall be \$1000.00.

(d) Class D licenses which shall authorize the retail sale of alcoholic liquors by clubs and to members only to be consumed in the club rooms only. The annual license fee shall be \$750.00.


