

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO
THE CITY OF URBANA, ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1: The territory hereinafter described is owned by the City of Urbana and is contiguous, uninhabited, unincorporated territory located adjacent to the North boundary of the present City of Urbana.

Section 2: That it is for the best interests of the City of Urbana that said territory should be annexed to the City of Urbana.

Section 3: A map showing the location of said territory is hereto attached and made a part of this ordinance and the territory to be annexed is outlined in red on said map.

Section 4: That the following described real estate be and is hereby annexed to the City of Urbana:

Beginning at a point 16.5 feet West of the Southwest corner of the Northwest Quarter (NW $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section Seven (7), Township Nineteen (19) North Range Nine (9) East of the Third Principal Meridian in Champaign County, Illinois, thence North 327 feet, thence East 301.5 feet, thence South 327 feet to the South line of the said Northwest Quarter (NW $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$), thence West 301.5 feet to the place of beginning, containing 2.02 acres more or less, situated in the County of Champaign, State of Illinois.

Section 5: That a copy of this ordinance, together with the map of the annexed territory shall be forwarded to the Recorder of Deeds of Champaign County, Illinois, for recording.

Section 6: This ordinance shall be effective as of the date of its passage.

RESOLUTION NO. _____

WHEREAS, Housing Authority of Champaign County, has conveyed to the City of Urbana, the following described real estate, to-wit:

Beginning at a point 16.5 feet West of the Southwest corner of the Northwest Quarter (NW $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section Seven (7), Township Nineteen (19) North Range Nine (9) East of the Third Principal Meridian in Champaign County, Illinois, thence North 327 feet, thence East 301.5 feet, thence South 327 feet to the South line of the said Northwest Quarter (NW $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$), thence West 301.5 feet to the place of beginning, containing 2.02 acres more or less, situated in the County of Champaign, State of Illinois;

in order that the said property may be annexed to the City of Urbana to enable the Housing Authority of Champaign County to proceed with plans for the erection of low rental dwelling units thereon; and

WHEREAS, the City of Urbana desires to aid and cooperate in the planning and construction of said housing units; and

WHEREAS, said real estate has now been annexed to the City of Urbana; and

WHEREAS, the property must be reconveyed to the Housing Authority of Champaign County in order for them to proceed with the construction of said low-rent housing units; and

WHEREAS, the City has power to convey said real estate pursuant to the provisions of the housing cooperation law of the State of Illinois.

THEREFORE, BE IT RESOLVED, that the City of Urbana convey to the Housing Authority of Champaign County for the sum of One Dollar (\$1.00) and other good and valuable consideration, the following described real estate, to-wit:

Beginning at a point 16.5 feet West of the Southwest corner of the Northwest Quarter (NW $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section Seven (7), Township Nineteen (19) North Range Nine (9) East of the Third Principal Meridian in Champaign County, Illinois, thence North 327 feet, thence East 301.5 feet, thence South 327 feet to the South line of the said Northwest Quarter (NW $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$), thence West 301.5 feet to the place of beginning, containing 2.02 acres more or less, situated in the County of Champaign, State of Illinois.

BE IT FURTHER RESOLVED, that the Mayor of the City of Urbana, be and is hereby authorized and directed to execute for and on behalf of the City of Urbana, a good and sufficient Quit Claim Deed, conveying the above described real estate to the Housing Authority of Champaign County, and that the City Clerk of the City of Urbana be and she is hereby authorized and directed to affix the corporate seal of the City of Urbana to said deed and duly attest the same.
