

**AN ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA, ILLINOIS**

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that a petition was filed with the City Clerk of the City of Urbana, Illinois on the 7th day of July, A. D. 1952, requesting the annexation of the territory hereinafter described, which said petition was signed under oath by Benjamin B. Bunn, Dorothy H. Bunn, H. J. Coopridier and Berniece Coopridier, the owners of all of said real estate in said territory in which there are no electors residing; and

Whereas, more than two-thirds of the aldermen are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois that said territory, and also the West Thirty-three feet (33') of a northerly extension of Coler Avenue from the present city limits to the north line of the Southwest Quarter of the Northwest Quarter of Section Eight (8) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian and also the north Thirty-three feet (33') of the Southwest Quarter of the Northwest Quarter aforesaid between Lincoln Avenue and Coler Avenue extended, be annexed to, and made a part of the city limits of said city.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That the territory described as follows, to-wit:

Beginning on the west line of the Southwest Quarter of the Northwest Quarter of Section Eight (8) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian at a point Four Hundred Sixty-eight feet (468') north of the Southwest corner of said Southwest Quarter of the Northwest Quarter of said Section, thence easterly one Hundred Eighty-three feet (183'), thence southerly Eight feet (8'), thence easterly Three Hundred Thirty-five and Two Tenths feet (335.2'), thence northerly Eight One Hundred Forty-four and Eight Tenths feet (144.8'), thence easterly One Hundred Seventy-one and Seventy-five One Hundredths feet (171.75'), thence southerly Two Hundred Seventy-five feet (275'), thence easterly Three Hundred Three feet (303'), thence northerly Eight Hundred Eighty-five and Forty-nine One Hundredths feet (885.49'), thence westerly Three Hundred Three feet (303'), thence northerly Eighty feet (80'), thence westerly Six Hundred Ninety feet (690'), thence southerly to the place of beginning, situated in the County of Champaign and State of Illinois, and also the west Thirty-three feet (33') of a northerly extension of Coler Avenue from the present city limits to the north line of the Southwest Quarter of the Northwest Quarter of Section Eight (8) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian and also the north Thirty-three feet (33') of the Southwest Quarter of the Northwest Quarter aforesaid between Lincoln Avenue and Coler Avenue extended.

be, and the same is hereby annexed to, and shall hereafter be a part of the City of Urbana, Illinois, and that the corporate limits of said city be, and

the same shall be changed so as to include said territory within the corporate limits of said City.



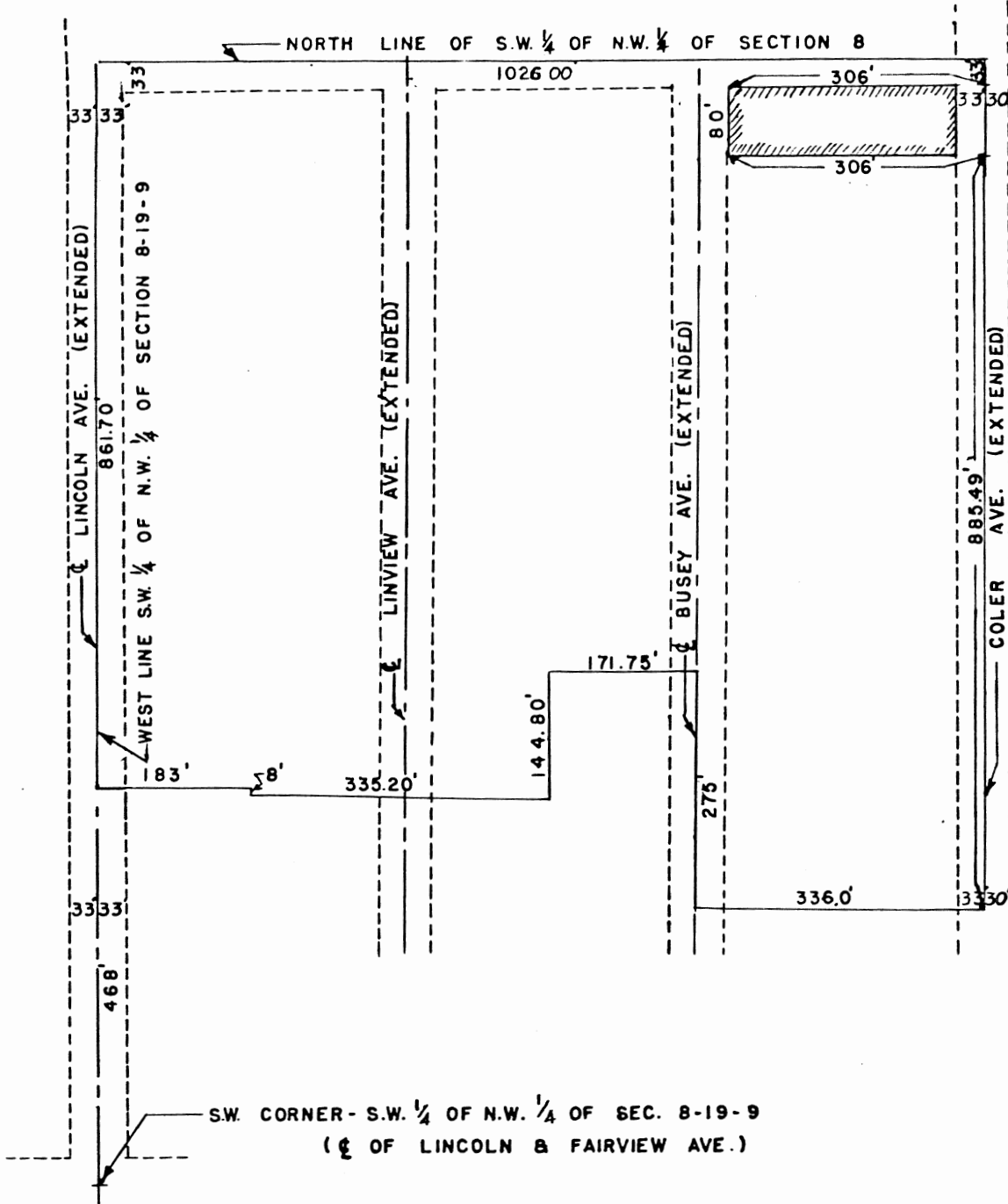
