

AN ORDINANCE ANNEXING CERTAIN TERRITORY  
TO THE CITY OF URBANA, ILLINOIS

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that a petition was filed with the City Clerk of the City of Urbana, Illinois on the 30<sup>th</sup> day of August, A. D. 1952, requesting the annexation of the territory hereinafter described, which said petition was signed under oath by O. S. Carman, Cecelia Carman, Rose Higgs and C. M. Higgs, the owners of all of said real estate in said territory in which there are no electors residing; and

Whereas, more than two-thirds of the aldermen are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois that said territory be annexed to, and made a part of the city limits of said city.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That the territory described as follows, to-wit:

Commencing at the southwest corner of lot twenty-five (25) of O. S. Carman's Second Subdivision, thence north four hundred seventy-seven and five tenths feet (477.5') to the northwest corner of lot one (1) of said O. S. Carman's Second Subdivision, thence east one hundred twenty-seven feet (127'), thence south nine and eighty-four one hundredths feet (9.84'), thence east one hundred thirty- feet (130') to the northeast corner of lot one (1) of O. S. Carman's Third Subdivision, thence south three hundred sixty-seven and seventy-six one hundredths feet (367.76') to the northwest corner of lot eight (8) of said O. S. Carman's Third Subdivision, thence east one hundred sixty-two and six tenths feet (162.6') to the northeast corner of lot ten (10) of said O. S. Carman's Third Subdivision, thence south one hundred thirty- feet (130') to the center line of Fairview Avenue, thence west along the south line of the northeast quarter of section seven (7) township nineteen (19) north, range nine (9) east of the third principal meridian, four hundred twenty-two and six tenths feet (422.6') to a point thirty- feet (30') south of the southwest corner of lot twenty-five (25) of O. S. Carman's Second Subdivision, thence north thirty- feet (30') to the place of beginning;

be, and the same is hereby annexed to, and shall hereafter be a part of the City of Urbana, Illinois, and that the corporate limits of said city be, and the same shall be changed so as to include said territory within the corporate limits of said city.

SECTION 2. The City Clerk of the City of Urbana, Illinois, shall record with the Recorder of Deeds of the County of Champaign, Illinois, a copy of this ordinance, together with an accurate map of the annexed territory.



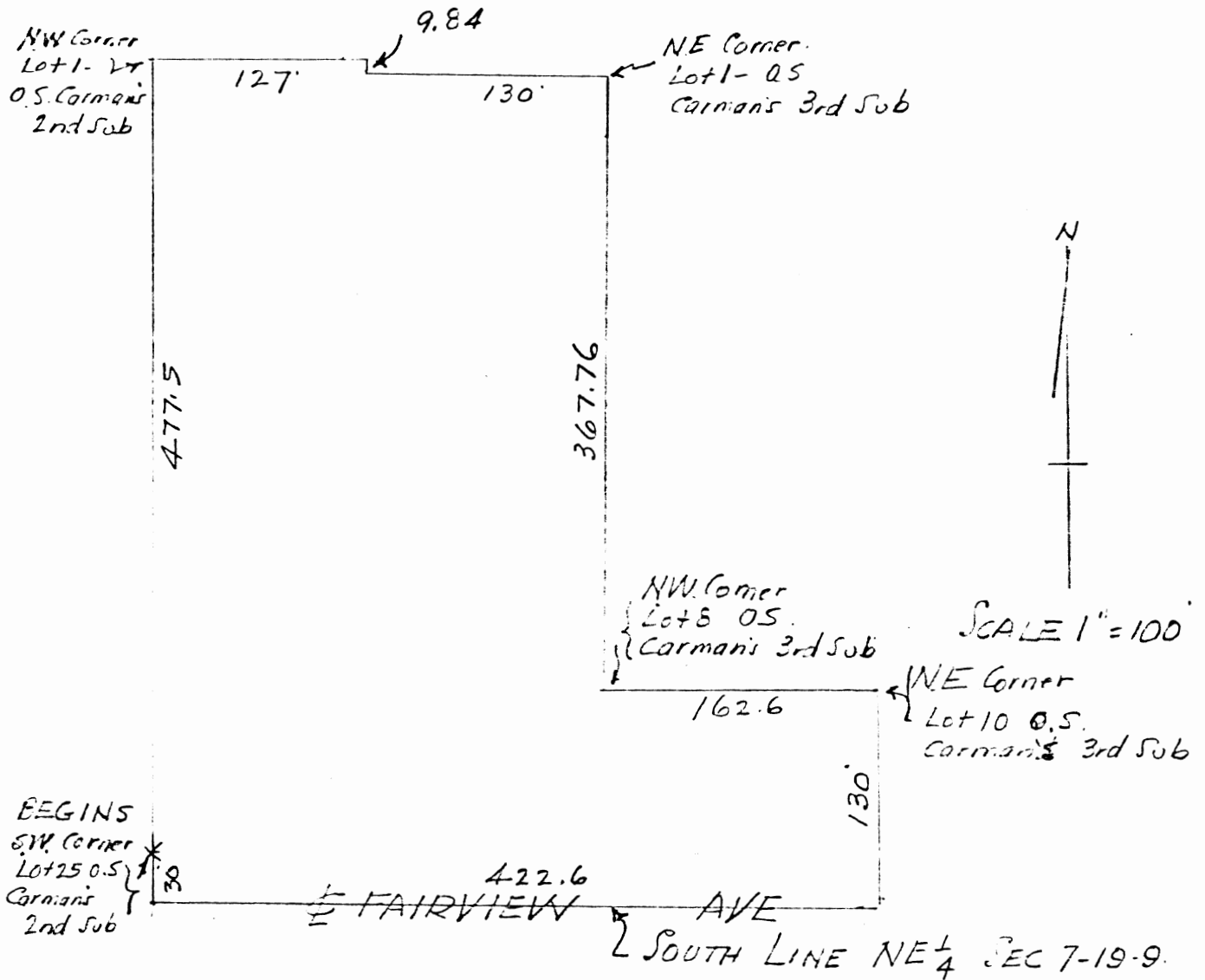
