

AN ORDINANCE VACATING AN ALLEY

WHEREAS, the adjoining property owners have, by proper petition, requested the City Council of the City of Urbana, Illinois to vacate the following described alley, to-wit:

The alley which runs from the east line of Lynn Street to the west line of Johnson Avenue along the rear boundaries of lots one (1), two (2), three (3) and four (4) of block four (4) of Teddy G. Johnson's Addition, and along the north boundary line of lots five (5) and eighteen (18) of block four (4) of said addition,

which said alley is located approximately one hundred thirty feet (130) south of the south line of Green Street and which is twelve feet (12') in width; and

Whereas, it appears that there are no objectors to the closing of said alley, but that the owners of all of the properties which could possibly be served by said alley have joined in the petition for the vacation thereof; and

Whereas, it appears that said alley has no useful purpose, but that it would be for the best interests of the people of the City of Urbana that said alley be vacated, and

Whereas, three-fourths (3/4) of the aldermen elected or authorized to be elected to the City Council of the City of Urbana find that said alley should be vacated.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:


SECTION 1. That the City Council of the City of Urbana, Illinois, does hereby vacate and release to the owners of the abutting property, all right, title and interest of the City of Urbana to the alley described as follows:

Commencing at the southwest corner of lot four (4) of block four (4) of Teddy G. Johnson's Addition to the City of Urbana, Illinois, thence south twelve feet (12'), thence east two hundred seventeen feet (217') to the northeast corner of lot eighteen (18) of block four (4) of said addition, thence north twelve feet (12'), thence west two hundred seventeen feet (217') to the place of beginning, situated in the City of Urbana, County of Champaign and State of Illinois.

SECTION 2. There is hereby reserved for public use, an easement in, under, through and across said alley for the benefit of any public utility companies having public facilities in said alley for the purpose of continuing public service by means of those facilities and for the maintenance, renewal and reconstruction thereof.


SECTION 3. This ordinance shall take effect and be in force from and after its passage and approval as required by law.
