AN ORDINANCE AMENDING THE ANNUAL APPROPRIATION

ORDINANCE OF THE CITY OF URBANA, ILLINOIS

FOR THE YEAR BEGINNING MAY 1, 1952 AND ENDING APRIL 30, 1953

WHEREAS, the City Council of the City of Urbana, Illinois, did on the 21st day of July, A. D. 1952, adopt an ordinance entitled, "Annual Appropriation Bill of the City of Urbana, Illinois for the Year Beginning May 1, 1952 and ending April 30, 1953," and

Whereas, said Ordinance provided in Section 14 thereof as follows:

"SECTION 14. Nothing herein shall be construed as prohibiting the redistribution of the funds herein appropriated, so that the amount herein appropriated for any express purpose, which shall later be found to be in excess of the amount actually needed for such purpose, may be allotted and added to the amount herein appropriated for some other express purpose which shall later be found to be less than the amount needed for such purpose; nor shall the same be construed so as to prohibit the addition of any amounts from revenue which may be received hereafter, which are not at this time anticipated or foreseen; nor shall anything herein be construed to prohibit the right to make such redistribution and allotment of the funds herein appropriated when the same have been found to be greater than or less than the amounts actually needed for the purpose for which such amounts were appropriated." and

Whereas, it appears that insufficient amounts were appropriated for certain departments of said City hereinafter mentioned and that excess funds were appropriated for certain departments hereinafter mentioned so that it is possible to redistribute such excess amounts to the departments for which insufficient funds were appropriated.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That the Annual Appropriation Bill of the City of Urbana, Illinois for the year beginning May 1, 1952 and ending April 30, 1953, is hereby amended as follows:

Section 1. \$2,500 of the funds appropriated to the Street Department under Paragraph 1 of said Ordinance are hereby redistributed and appropriated for the purposes of Police Protection as set forth in Section 11 of said Ordinance.

Section 2. \$100 of the amount appropriated for the current expenses of the Street, Alley Sewerage and Drainage Department as shown in Paragraph 1 of said Ordinance are hereby redistributed and appropriated for the current expenses of the Lights and Electrical Service Department as shown in Paragraph 6 of said Ordinance.

Section 3. \$200 of the funds appropriated for the current expenses of the Street. Alley. Sewerage and Drainage Department as shown in Paragraph 1 of said Ordinance are hereby redistributed and appropriated for the purposes of paying the expenses of elections as shown in Paragraph 7 of said Ordinance.
