AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF URBANA, ILLINOIS

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that a petition was filed with the City Clerk of the City of Urbana, Illinois on the total day of July, A. D. 1953, requesting the annexation of the territory hereinafter described, which said petition was signed under oath by David F. Hubbard, and Howard O. Watson, the owners of all of said real estate in said territory in which there are no electors residing; and

Whereas, more than two-thirds of the aldermen are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois that said territory be annexed to, and made a part of the city limits of said city.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That the territory described as follows, to-wit:

Beginning at a point One Hundred Seventy-three feet (173*) East of the West line of the Southeast Quarter of the Northeast Quarter of Section Twenty (20) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, and Thirty-three feet (33*) North of the Northeast corner of Lot One Hundred Thirty-eight (138) of University Downs Sixth Plat, thence South along the East line of University Downs Sixth Plat, on an assumed bearing of South 00000 East a distance of Eight Hundred Ninety-eight and Forty-eight Hundredths feet (898.48*), thence North 50°37° East a distance of One Hundred Ninety-five and Forty-one Hundredths feet (195.41°), thence South 39°23° East a distance of Sixty feet (60°), thence North 50°37° East a distance of One Hundred Thirty and Fiftythree Hundredths feet (130.53*), thence North 0000, East a distance of Thirty-three and Seventy-three Hundredths feet (33.73), thence South $89^{\rm o}44^{\rm t}$ East a distance of One Hundred Seventy-five feet (175°), thence North 0°00° East a distance of One Hundred feet (100°), thence South 89°44° East a distance of One Hundred Fifteen feet (115°), thence North 0°00° East a distance of Six Hundred Three feet (603°), thence North 89°44° West a distance of Five Hundred Eighty feet (580°), to the place of beginning containing Nine and Eight Hundred Fifty-nine Thousandths (9.859) acres, situated in Champaign County, Illinois,

be, and the same is hereby annexed to, and shall hereafter be a part of the City of Urbana, Illinois, and that the corporate limits of said city be, and the same shall be changed so as to include said territory within the corporate limits of said city.

SECTION 2. The City Clerk of the City of Urbana, Illinois, shall record with the Recorder of Deeds of the County of Champaign, Illinois, a copy of this ordinance, together with an accurate map of the annexed territory.
