AN ORDINANCE ADDING CERTAIN TERRITORY TO THE SEVENTH WARD OF THE CITY OF URBANA, ILLINOIS

WHEREAS, the City Council of the City of Urbana, Illinois, did on the 17th day of November A. D. 1952, adopt an ordinance changing the boundaries of wards within the City of Urbana, Illinois, wherein said wards are specifically described by metes and bounds; and

WHEREAS, there was by ordinance adopted on the 17th day of August A. D. 1953, annexed to the corporate limits of said City the territory hereinafter described, which said territory is not presently included within any of the seven wards of said City; and

WHEREAS, the hereinafter described territory is contiguous to the area included in the seventh ward of the said City.


NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That an ordinance changing the boundaries of wards within the City of Urbana, Illinois, adopted by the City Council of said City on the 17th day of November A. D. 1952, is hereby amended by including within the seventh ward of said City, the following described territory, to-wit:

Commencing at a point on the East line of University Downs Sixth Plat Three Hundred Thirty-eight feet (338') South of the North line of the Southeast Quarter of the Northeast Quarter of Section Twenty (20) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence West to the West line of Vine Street, thence South to the Southeast corner of Lot One Hundred Twenty-nine (129) of University Downs Fourth Plat, thence West to the Southwest corner of said Lot One Hundred Twenty-nine (129), thence in a Northwesterly direction along the back lines of said Lots One Hundred twenty-nine and One Hundred Thirty (130) of University Downs Fourth Plat to the Northwest corner of said Lot One Hundred Thirty (130), thence East to the West line of Vine Street, thence North along the West line of Vine Street to a point One Hundred Seventy-five feet (175') South of the North line of the Southwest Quarter of the Northeast Quarter of said Section Twenty (20), thence East to a point on the East line of University Downs Sixth Plat One Hundred Seventy-five feet (175') South of the North line of the Southeast Quarter of the Northeast Quarter of said Section Twenty (20), thence South Two Hundred Thirteen feet (213') to the place of beginning,


containing Lots One Hundred Forty (140) One Hundred Forty-one (141) and One Hundred Forty-two (142) of University Downs Sixth Plat, and Lots One Hundred Twenty-nine (129) and One Hundred Thirty (130) of University Downs Fourth Plat and a portion of Vine Street, all in Champaign County, Illinois.
